Sir,

With reference to the subject & your letter cited above, the matter was discussed in the 40th meeting of SEIAA & on the recommendation SEAC, following amendments are made in the conditions of environmental clearance issued vide this Authority's letter of even number dated 29.12.2009:-

1. No. of Floors could be G + 8 in proposed Software Development Block (SDB) but the total built up area would remain the same that is 1,28,723.4 mt. sq. The no. of storeys in rest of the buildings would be kept accordingly.
2. The revised plan should be approved by the related authorities before implementation.
3. The maximum building height would be 28 mts. in rest of all the building and 40 mts. in case of Software Development Block (SDB).
4. That the grant of this E.C. is from the environmental angle only, and does not absolve the project proponent from the other statutory obligations prescribed under any other law or any other instrument in force. The sole and complete responsibility, to comply with the conditions laid down in all other laws for the time-being in force, rests with the industry / unit / project proponent.
5. Other conditions will remain as such.
