Office Memorandum


In compliance with the office memorandum issued by Central Pollution Control Board, Delhi No.B-33014/7/2006/PCI-II/1900 dated 02.06.2014 and notification dated 01.08.2014 issued by Department of Environment, Government of Rajasthan, Jaipur under the provision of Rajasthan Water (Prevention and Control of Pollution) Rules, 1974 and Rajasthan Air (Prevention and Control of Pollution) Rules, 1983, the State Board in partial modification to office order No.- F. 14(23)/RPCB/Policy/Plg/6969-7004 dated 13/08/2014, makes following amendments in the categorization of Industries issued vide this office order No. F 14(23) RPCB/Policy/Plg/10548-10587, dated 07/03/2013,

- 1) Under the list of Red category industries at S. No.- 32 shall be substituted by:-
“Industrial Estate/ Parks/ Complexes/ Areas/ Export Processing Zones/ SEZs/ Biotech Parks/ Leather Complexes except solar/ wind Industrial Estate/ Parks/ Complexes/ Areas upto 500 hectares.”
- 2) Under the list of Green category industries S. No.- 79 shall be substituted by:-
“Wind and Solar renewable power projects of all capacities, Mini Hydel power plants of less than 25 MW capacities and Wind and Solar Industrial Estate/ Parks/ Complexes/ Areas upto 500 hectares.”

Solar/ wind Industrial Estate/ Parks/ Complexes/ Areas more than 500 hectares will continue to be under Red category as such projects are covered under EIA Notification, 2006 at S. No.- 7(c) of Schedule- I.

This amendment in categorization shall come in to force with immediate effect.

This bears the approval of the competent authority.


