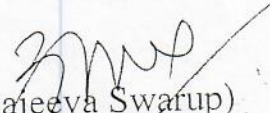
3. The Rajasthan Crafts Council will advise the State Government in respect of the following areas:

- (a) Design, Innovations, and Product & Skill Development
- (b) Quality Control and Branding
- (c) Credit Access and Assistance
- (d) Market access and linkages for sustainable livelihood, including e-commerce
- (e) State and District-wise Inventory of Crafts and artisans
- (f) Cluster Development
- (g) Any other related subject assigned by the Chairperson or the State Government

4. The Council will have an Executive Committee. In addition, the Chairperson may constitute Working Groups / Sub Groups as may be considered necessary and may also co-opt members for specific inputs.

5. Meetings of the Rajasthan Crafts Council will be convened as often as required. The Office of Commissioner, Industries, Government of Rajasthan, will serve as the Secretariat of the Rajasthan Crafts Council.
