भारतीय हाथकरघा प्रौद्योगिकी संस्थान, जोधपुर से हाथकरघा प्रौद्योगिकी में त्रिवर्षीय डिप्लोमा कोर्स के प्रथम वर्ष में आवेदन करने की अन्तिम तिथि 27 जुलाई 2020 सोमवार है।

भारतीय हाथकरघा प्रौद्योगिकी संस्थान, राधाकृष्णापुरम चौपासनी चौखा रोड, जोधपुर -342001 राजस्थान में त्रिवर्षीय (6 सेमेस्टर) हाथकरघा एवं वस्त्र प्रौद्योगिकी डिप्लोमा पाठ्यक्रम में प्रथम सेमेस्टर में प्रवेश हेतु आवेदन पत्र आमन्त्रित किये जाते हैं।

1. राजस्थान राज्य कोटे हेतु आवंटित कुल सीटें - 16
2. आवेदन हेतु पात्रता मापदण्ड
 - अ- अभ्यार्थी सैकण्डरी या समकक्ष उत्तीर्ण होना चाहिए तथा इस परीक्षा में अंग्रेजी एक अध्ययन का विषय रहा हो।
 - ब- आयु सीमा-अभ्यार्थी की दिनांक 01.07.2020 को आयु न्यूनतम 15 वर्ष एवं अधिकतम 23 वर्ष एवं अनुसूचित जाति/ जन जाति के अभ्यार्थियों के लिए न्यूनतम 15 वर्ष एवं अधिकतम 25 वर्ष तक होनी अनिवार्य है।
 - स- राज्य सरकार की नीति अनुसार अ.जा./ज.जा./ अन्य पिछड़ा वर्ग के लिये नियमानुसार आरक्षण रहेगा।
 - द- बुनकर समुदाय के अभ्यार्थियों हेतु कुल सीट का 20 प्रतिशत आरक्षण रहेगा। इस समुदाय के पर्याप्त संख्या में अभ्यार्थी नहीं मिलने पर शेष रिक्तियां अन्य श्रेणी से भरी जायेगी।
 - य- अन्तिम तिथि- आवेदन पत्र निर्धारित प्रपत्र में मय शैक्षणिक योग्यता प्रमाण पत्रों के दिनांक 27 जुलाई 2020 सोमवार तक जिला उद्योग केन्द्र, न्यू पावर हाउस रोड, मिनी उद्योग भवन, जोधपुर में अवश्य प्राप्त हो जाना चाहिए। इसके पश्चात प्राप्त आवेदन पत्रों पर विचार नहीं किया जायेगा।

विशेष :-

- 1- प्रवेश प्राप्त करने वाले विद्यार्थी को सरकार द्वारा निर्धारित दर से स्टाईफण्ड प्राप्त होगा।
- 2- त्रिवर्षीय डिप्लोमा कोर्स उत्तीर्ण विद्यार्थी संबंधित ब्रान्च में इंजीनियरिंग पाठ्यक्रम में द्वितीय वर्ष में प्रवेश हेतु आवेदन करने के लिये भी पात्र होते हैं।

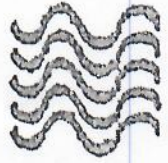

Sub: Selection of candidates for admission to the First Year of Three Years Diploma course in Handloom & Textile Technology (DHTT) for the session 2020-21 regarding.

Dear Sir,

The next session of the First Year of Three Years Diploma course in *Handloom & Textile Technology* at this Institute will tentatively commence from 16th July 2020. For selection of candidates to the First Year DHTT Course following guide lines are to be observed:-

1. Eligibility criteria

- (i) **Educational qualifications:** To be eligible for admission to first year of Diploma Course in Handlooms & Textile Technology, the candidate should have passed 10th standard or equivalent examination with English as a subject of study.

NOTE: Some Board has already introduced the system of grading in 10th Examination. As such candidate must endorse the proof of details of marks with their application form to enable the selection committee to prepare merit list which is prepared on the basis of marks secured in 10th examination only.

- (ii) **Age limit:** The age limit for admission to first year of Diploma Course in Handlooms & Textile Technology for all the categories except SC/ST should be between 15-23 years and for SC/ST candidates it should be between 15-25 year as on 01-July of the admission year.

2. Reservation

- (i) The respective State Governments will follow their reservation policies for SC/ST/OBC etc.
- (ii) In addition to above, minimum 20% of the total seats allotted to the states are reserved for candidates belonging to Weavers Community. Shortfall if any will be met out from the candidates other than weaver's community.

3. Numbers of seats

- (i) Govt. of India has allotted 16 seats for your state.

4. Form of application

- (i) The respective state governments will invite applications for admission to first year of Diploma in Handloom & Textile Technology either through press or other Media publicity in the prescribed application form (copy enclosed.) latest by **15th May 2020**.
- (ii) A copy of the advertisement shall be sent to this office immediately after it's publication.
- (iii) The filled-in applications should be received by your office latest by **15th June 2020**.

5. Preparation of merit list

- (i) Merit List of all the eligible candidates will be prepared by the Selection Committee comprising Director of Handlooms Textiles/Director of Industries & Director, IIHT, Jodhpur or his representative subject to satisfy the qualifying standard and other eligibility conditions and depending upon the State reservation policy. A common merit list of all eligible candidates irrespective of categories will be prepared & shall be submitted to reach this office latest by 20th June, for issue of offer of counseling to the eligible candidates.
- (ii) Aggregate of marks obtained in class 10th or equivalent qualifying examination shall be basis for the purpose of determining the merit.
- (iii) State Government should decide and mention the actual no. of seats to be reserved for various categories as per their prevailing reservation policy and for weavers community out of total seats allotted to the state.
- (iv) In the event of two candidates securing identical marks in aggregate then the candidate who had secured more marks in the Science subject will stand higher in the merit.
1. If under extra ordinary circumstances the above conditions also remain identical, the eligible candidate having less age will be on higher merit. However, even if this also remains identical, the alphabetical order of the name of the candidates will be criteria for merit i.e. English alphabet A to Z.

6. Counseling

- (i) After receiving the merit list form the State Government the Director, Indian Institute of Handloom Technology concerned will invite the candidates for Counseling at the Institute itself under intimation to concerned state government *in the ratio of 1:3 of the seats allotted to respective state.*

- (ii) Counseling Committee will comprising of **Director, Assistant Director or Senior Lecturer of Institute concerned and Director of Handlooms & Textiles of the concerned State or his representative.** The candidates shall be required to produce all certificates in original such as educational, caste, domicile, character and medical certificate with one additional attested photocopy of each and four copies of his photograph identical to the one pasted on the application form at the time of counseling/ grant of admission.
- (iii) A candidate who is allotted a seat will be required to pay admission fee only in cash/demand draft immediately on the spot at the time of counseling/admission. The fee structure will be intimated to the candidate in the counseling letter. Part payment will not be accepted. If a candidate fails to pay the fee, immediately after the seat is offered to him/her, the offer will be withdrawn and the seat will be allotted to the next candidate in the merit list. In case a candidate drops out after taking admission, his/her full fee will be forfeited.
- (iv) A candidate, who fails to appear in person on the notified date and time for counseling, shall forfeit his/her claim for the seat offered to him/her and such seat will be offered to the next candidate in the merit.
- (v) Vacancies arising due to cancellation/any other reasons for admission in DHTT course will be calculated and notified. Remaining candidates of concerned state in the merit list, who could not get chance in 1st Counseling due to their lower position in the merit list, will be invited in 2nd counseling along with candidates in the combined merit list of all the wait listed candidates of all the states under the jurisdiction of this Institute. (if required to be operated)
- (vi) In case the seats are not filled even after the list of the eligible candidates of the state and the combined merit list of all the wait listed candidates of all the states is exhausted then inter Institute-wise merit list of eligible candidates will be prepared and 3rd Counseling would be conducted as per the above procedure.

NOTE: No TA/DA will be given to candidates for attending the counseling.

7. Stipend

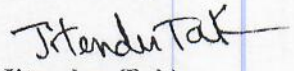
Each student admitted into the course will be eligible for Stipend of Rs. 1000/- in First Year, Rs. 1100/- in 3rd & 4th Semester & Rs. 1200/- in 5th & 6th Semester. However, he/she will be paid Rs. 500/- per month in First Year, Rs. 550/- per month in 3rd & 4th Semester [second year] & Rs.600/- per month in 5th & 6th Semesters [third year] as 50% Central Share of Stipend by this office and remaining 50% i.e.500/-, 550/- & 600/-, as the case may be, towards State Share of Stipend will be paid to the students as soon as the same is received from the concerned State Govt., for the duration of course (tenable for 10 months from 16th July to 15th May). The student selected for admission will be required to submit a declaration on a non-judicial stamp-paper (Rs. 100/-) duly attested by Notary in the prescribed form.

Since Government has allotted 16 seats to your state as such you will have to reimburse the stipend @Rs.500/- per month for First Year for each student for 10 months during this year i.e. 2020-21 @ Rs. 550/- in 3rd & 4th semester & @ Rs. 600/- for 5th & 6th semester. A detailed letter requesting to reimburse the actual amount of stipend, payable in a particular year will be intimated to you every year by this office. You will be required to send the amount through Demand Draft drawn on Central Bank of India, Jodhpur in favour of the Director, IIHT, Jodhpur.

You are requested to invite applications from deserving & eligible candidates in the prescribed form (copy enclosed) giving wide publicity through Press or other suitable media. A convenient date for preparation of merit-list may be fixed in Third week of June, 2020 but before 21st June, 2020 & same may kindly be communicated to this office. The merit list of candidates as mentioned in para 5(i) above along with their applications & enclosures may be forwarded to this Institute immediately to enable this office to issue the counseling letters to the candidates & counseling/admission may be completed on the dates as decided in the guidelines issued by Development Commissioner (Handlooms).

Note:- The date of admission in IIHT for DHTT students may vary due to present pandemic situation of COVID-19.

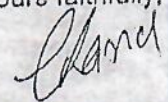
I am directed to refer to the Minutes of the 45th Governing Body Meeting held on 14.02.2012 on the above cited subject.
