### Inauguration of IT SEZ: A Milestone for Rajasthan

Smt. Vasundhara Raje, Hon'ble Chief Minister of Rajasthan, on Aug 29th 2008, inaugurated Mahindra World City (MWC), Information Technology Special Economic Zone (IT SEZ) at Jaipur. The IT SEZ covers an area of about 750 acres, making it the largest planned IT SEZ in the country. This IT SEZ is a part of the larger 3000-acre multi product SEZ Mahindra World City that would have exclusive zones for Light Engineering Companies, Auto Ancillary, Handicraft Companies as well as for the traditional Gems & Jewellery and Apparel Companies. The Domestic Tariff Area will cater to the demand of Domestic Industries. It will also provide end-to-end solutions to manufacturing companies by having a dedicated Logistics and Warehousing Zone.

On the occasion, Smt. Vasundhra Raje said, "Inauguration of

the IT SEZ in the Mahindra World City, Jaipur, is a significant milestone for Rajasthan. Today, Jaipur is one of the fastest growing cities of the country having excellent infrastructure facilities and provide a platform for corporates to set up their facilities, which will in turn generate job opportunities for people".

The IT SEZ has attracted Big Corporates, like Infosys, Deutsche Bank, Wipro, Nucleus Software and others. The SEZ will provide huge employment opportunities for the

people of Rajasthan. It is expected that by 2012, the SEZ will generate employment opportunity for more than 1 lakh people.

Mahindra World City is a shining example of Public- Private Partnership (PPP). This project is a 74:26 joint venture between Mahindra Lifespace Developers Ltd. (MLDL) and the Rajasthan State Industrial Development and Industrial Corporation (RIICO).

Foundation stone for the SEZ was laid down in December 2006, and it became operational within two

years, which is a remarkable achievement. In addition to the IT SEZ, various upcoming industries and corporate houses are coming in the near future in Jaipur.

Mr. Arun Nanda, Executive Director, Mahindra & Mahindra, said, "The tremendous support we received from the State Government, both at the policy and decision making level, has enabled this venture to be completed within two years."

Development of Mahindra World City is substantial evidence to the fact that Rajasthan is emerging as a preferred choice of investment for the big companies from every sector. Rajasthan Government's proactive efforts and determination in providing world-class infrastructure facilities as well as business environment has served as a testimony to this recognition.

## SGGI plans New Float in Bhiwadi Rajasthan

Saint-Gobain Glass India (SGGI), a fully-owned subsidiary of the Paris-based Euro 41 billion Saint-Gobain Group, is setting up a 300,000 tonnes per annum capacity glass plant in Rajasthan. This plant, which will be among the largest such plants anywhere in the world, will come up at Bhiwadi in Rajasthan The new unit, World Glass Complex, would house a multitude of manufacturing facilities.

In the first phase, investment will be around Rs.10 billion. The plant is expected to go on stream in the first quarter of 2010.

An MOU between the State government and Saint Gobain Glass India Ptd. (SGGIL) was signed at Jaipur on 19th August 2008 in the presence of Smt. Vasundhara Raje, Hon'ble Chief Minister Rajasthan.

# Deutsche Bank group opens service delivery hub in Jaipur

DBOI Global Services, the global processing arm of Deutsche Bank, inaugurated its global service delivery centre in Mahindra World City (MWC), Jaipur. Smt. Vasundhara Raje Hon'ble Chief Minister, Rajasthan, inaugurated the Centre at the Mahindra World City on 10th September 2008. It is their third centre after Mumbai and Bangalore in India and fifth in the world.

This state-of-the-art facility will house operational and support teams for Deutsche Bank. The centre will also deliver operations and business function solutions for several of the Bank's divisions, commencing initially with Investment Banking and Asset Management. DBOI Global Services expects to employ 500 professionals at its Jaipur facility by the end of the year.

## भामाशाह-महिला सशक्तिकरण की अभितव पहल

मुख्यमंत्री श्रीमती वसुंधरा राजे ने राज्य की महिलाओं को आर्थिक रूप से आत्मनिर्भर बनाने के उद्देश्य से भामाशाह महिला वित्तीय सशक्तिकरण व राष्ट्रीय स्वास्थ्य बीमा योजना की शुरुआत की है। इस महत्वपूर्ण कदम से राज्य की पचास लाख महिलाएं लाभान्वित होंगी। योजना के तहत बी.पी.एल. परिवारों, लघु एवं सीमांत कृषकों तथा चिह्नित अनुसूचित जाति और

जनजाति के परिवारों की महिलाओं के नाम से बायोमेर्टिक स्मॉर्ट कॉर्ड जारी किए जाएंगे। खाते खुलने पर राज्य सरकार द्वारा प्रत्येक महिला के खाते में एक हजार पांच सौ रूपये जमा करवाए जाएंगे। मुख्यमंत्री वसुन्धरा राजे ने अपने बजट भाषण में इस योजना की घोषणा की थी।

करीब साढ़े सात सौ करोड़ रुपए लागत की इस योजना का आधारभूत ढांचा तैयार करने की जिम्मेदारी राजस्थान सरकार ने भारत की बड़ी कम्पनी आईएलएफएस एवं बारटोनिक्स को सौंपी है। इस योजना से राजस्थान प्रदेश की पचास लाख महिलाएं अब गांव की ढ़ाणी में बैठे हुए ही, बिना किसी बिचौलिए के, अपना बैंकिंग कारोबार कर सकेंगी।
