Accordingly, para No.2 of page 2 of the scheme circulated vide Circular No P&G 1211 dated 1.12.2007 may be substituted as under:

"Rowever, if the units/promoters whose loan a/c has been rescheduled applies for loan under "Saral Scheme for existing running industrial units". them, while processing the loan application it may be ensured that the unit has paid the dues strictly on due dates in terms of reschedulements for a

The amended parameters shall be applicable with immediate effect.
