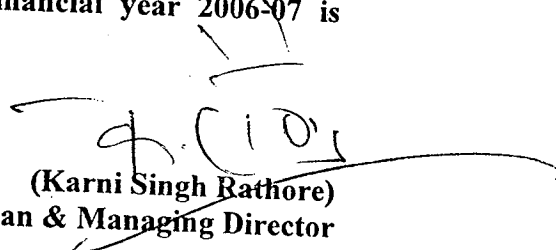

Reg : Legal action Under Section 32(G) of SFCs Act

Section 32(G) u/s SFCs Act, 1951 played an effective/important role for reducing NPA percentage for the last two financial years, therefore, in order to further improve the recovery from existing NPA accounts, target for action to be initiated u/s 32(G) for the financial year 2006-07 are fixed.

After filing the case u/s 32(G), Branch Manager should follow-up all the cases with the official of District Administration so as to speed up the recovery u/s 32(G) for reducing the NPAs.
