The Corporation is commemorating the year 2006-07 the year of recovery and consolidation. The endeavour of the Corporation is to reduce the overall NPAs level atleast by 15% in absolute terms. Revised targets of recovery from non performing assets and deficit/decreetal/written off cases have been issued vide FR Circular No.414 dated 6.12.06 and No.415 dated 6.12.06 respectively. In order to achieve this object, CMD has decided to monitor the performance of recovery from non performing assets on regular basis.

To begin with, review of Branch Offices Bhiwadi, Abu Road, Alwar and Jodhpur is fixed for 21.12.06 and of Branch Offices Bhilwara, Jaipur(Rural), Pali and Udaipur for 22.12.06 at 11 AM.

For effective monitoring, the following information is needed which should be updated on fortnightly basis:

- a) List of NPA cases (excluding deficit/decreetal/written off) -(Annexure 'A')
- b) List of deficit cases (including decreetal/written off) Annexure 'B'.
- c) List of cases which were in standard category as on 31.3.06 but slipped to NPA during the year Annexure 'C'.
- d) List of cases which were under NPA category on 31.3.06 but upgraded to standard category during the year Annexure 'D'.
- e) List of cases sanctioned after 1.04.2000 and at present are NPA-Annexure 'E'.

All concerned are enjoined upon to call on the CMD on the scheduled date and time alongwith the entire information related to their Branch including the information, as above. Nodal officers concerned shall also remain present during the course of review.

Any laxity noticed in furnishing the required information shall be viewed seriously.
