Reg: Search / Identification of properties of defaulters and verification of their addresses

While going through the portfolio of the BOs under the DDW it has been observed that there is a substantial amount recoverable in Deficit / Decreetal / Write off accounts. Approximately the sum of Rs.163.45 crere is involved in such accounts as on 31.03.09. To accelerate the recovery in these accounts it has been decided that an on going exercise may be undertaken by the BOs to search out the properties and verification of addresses of the concerned loanees as well as their guarantors should be ascertained.

In view of above, following course of action should be initiated:

- 1) A strategy in this regard is to be framed wherein certain number of teams of the Branch Officials should be constituted.
- 2) This exercise for searching the properties shall be completed upto 30.06.09. During the visits by the teams, notice for recovery will be personally handed over to the loanee / guarantors by the team leaders.
- 3) The visit report will be prepared in two copies one for concerned file and another for DGM (FR-DDW) at H.O.
- 4) After completion of the above exercise for identification of properties / verification, action u/s 32-G should be initiated on priority and RoD should be sent to DGM (FR-DDW) within 10 days of all the eligible cases/information of properties identified be furnished to concerned Revenue Authorities for attachment action.

Format of visit report is enclosed which will be fulfilled by the team at the time of their visit. The visit report should be completely filled in and no column should be left blank.

In the light of above, this task will be completed by the BOs upto 30.06.09 so that maximum recovery can be effected and the allotted targets be also achieved by the BOs under this portfolio.

All concerned are advised to note above and ensure the compliance accordingly.
