The BM, Jaipur (Rural) and Branch Manager (Jaipur City) shall also provide vehicle for 15 days in a month for the purpose of regular follow-up of all 32(G) cases pending with the Revenue Authorities in Jaipur District.

The Official vehicle available at BO Kota will also be made available to SO,Bundi for five days in a month.

All concerned are advised to make a note of above and ensure that targets in Key Areas of all the FR activities are achieved and record of vehicle and recovery effected is maintained.
