Sub: Compliance of direction of Hon'ble Rajasthan High Court, Jodhpur for timely disposal of representations.

The Hon'ble Rajasthan High Court, Jodhpur in the SBCWP No. 9034/2012 of Dhannaram Vs. State. has taken it very seriously that Government Authorities are not deciding representations promptly due to which litigations are increasing and accordingly the Hon'ble Court has passed following direction in the case:-

"...In number of writ petitions filed by the litigants, the fact comes out that government authorities are not deciding the representations promptly, therefore, litigation is increasing. In view of the above, I deemed it appropriate to issue direction to the Government that necessary instructions may be issued to all the Heads of Departments of the Government that in the event of receiving representations from employees for redressal of their grievance, those representations should be decided promptly within reasonable time preferably within two months and in contravention of above directions, the disciplinary action would be taken against them. The copy of this order may be sent to the Chief Secretary, Government of Rajasthan to issue above instructions to all the Departments of State Government for compliance..."

In this regard, Industries (Group-1) Department, Government of Rajasthan vide their letter No. P.7(56)Udyog/1/2013 dated 29th June, 2015 has forwarded copy of order No. P.7(56)Udyog/1/2013 dated 29th June, 2015 of Law & Legal Affairs Department, Govt. of Rajasthan directing that all the representations/demands of justice received from any employee/litigant/party, should be disposed of immediately after taking necessary action so that litigation is minimized. It has further been directed that in case of non-compliance of the direction, disciplinary action be initiated against the concerned defaulting official. Copy of the said order is enclosed for ready reference.

Accordingly, all concerned are advised to strictly comply with the directions of the Hon'ble High Court, Jodhpur as well as State Govt. to avoid unpleasant situation.
