- 3. Tour should be undertaken by Public Transport (Train/Bus) only as per entitlement.
- 4. Journey by hiring taxi/office vehicle/own vehicle within jurisdiction of Branch for the recovery/business purpose is permitted subject to budget provisions approved and guidelines issued in this regard by HO.
- 5. Journey by hiring taxi/office vehicle/own vehicle outside the jurisdiction of branch is not permitted. If the journey is proposed to be undertaken by hiring taxi/office vehicle/own vehicle, prior approval of MD/CMD is required
- 6. Journey by Air can be performed only after approval of MD/CMD.
- 7. Prior approval of Competent Authority is required before undertaking the tour.
- 8. Other provisions/guidelines issued in this regard shall remain unchanged.
