- 1. The instrument shall be purchased with one year warranty support at RFC, Udyog Bhawan, Jaipur

- 3. Quotation should be made in the name of DGM(GAD), Rajasthan Financial Corporation, Head Office, Udyog bhawan, Jaipur.
- 4. The delivery within 10 days from date of order.
- 5. Payment will be made within 30 days of supply, installation and testing of machines.
- 6. The MD has the right to cancel the procurement process at any point of time without assigning any reason thereof.
- 7. The rates shall be inclusive of all machine related parts, cables and installation.
- 8. Machines will be repaired in authorized service centers only within 24 hours.
- 9. The successful bidder will have to deposit security money 5% of bid value. Security money shall be refunded after expiry of warranty period i.e. one year.
