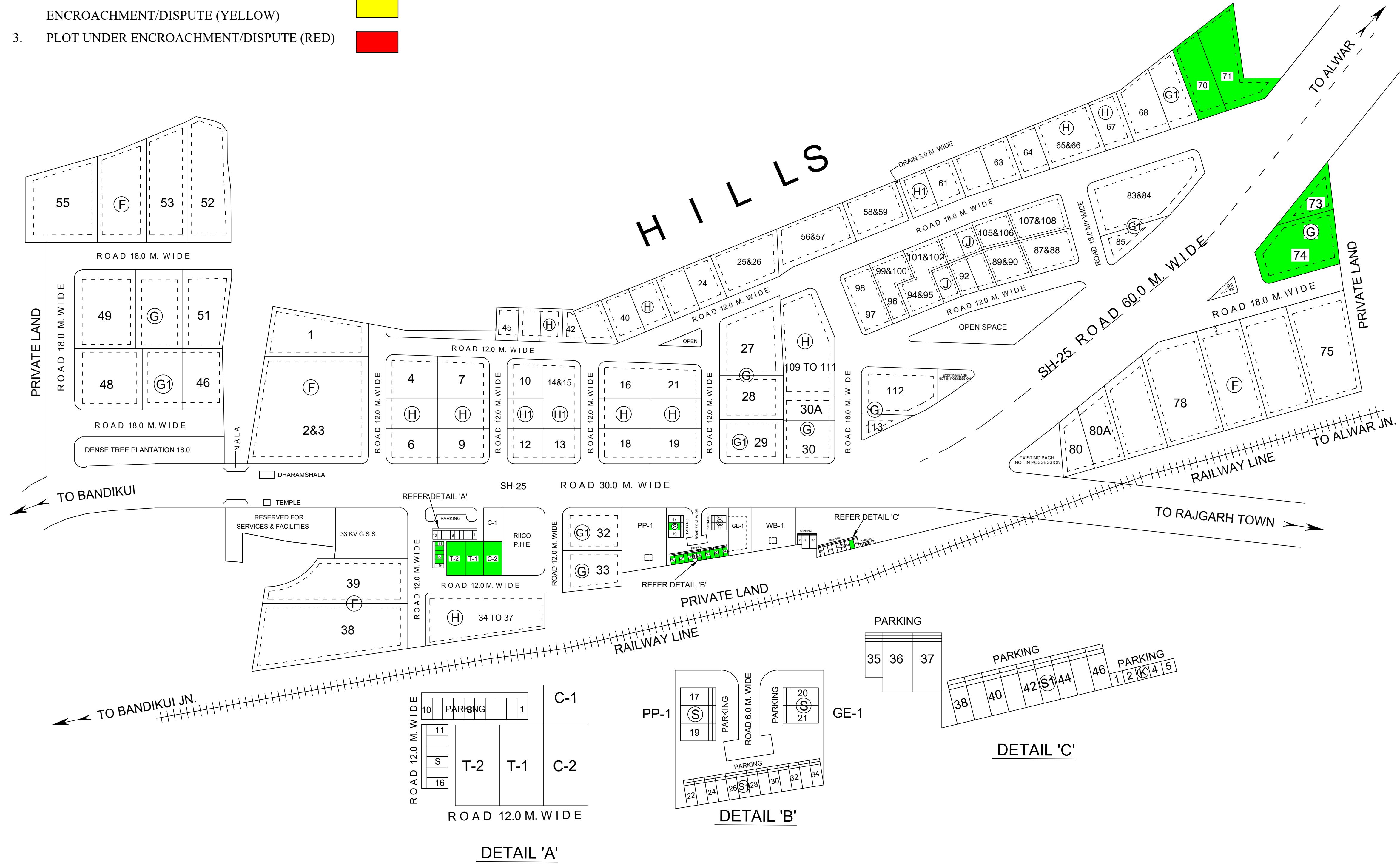


LEGEND :-
