

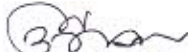

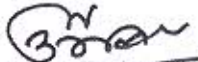

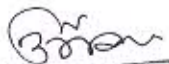

Corrigendum

Manager (HRD/GAD/Infra) & Jr. Legal Officer and amending the existing schedule of Assistant Accounts Officer Grade-II (hitherto known as Accountant).

Accordingly, office order of even no. dated 20.1.2014 has been issued. Inadvertently, in the Schedules for the post of Dy. Manager (HRD/GAD/Infra) and Jr. Legal Officer the criteria for 'Recruitment by Selection' has not been mentioned and in the Schedule for the post of Assistant Accounts Officer (Grade-II) 'Note' has been inserted in the criteria of 'Recruitment by Selection' instead of criteria of 'Direct Recruitment'.
