Office Order

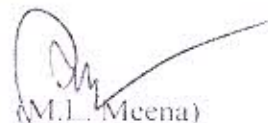
State Government has enacted an Act namely Rajasthan Transparency in Public Procurement Act, 2012 by way of Notification No. F.2(27)Vidhi/2/12 dated 22.05.2012 to regulate public procurement with objective of ensuring transparency, enhancing efficiency and safe guarding integrity in procurement process. As per provisions of clause-17 of Rajasthan Transparency in Public Procurement Act, 2012 (available on website www.finance.rajasthan.gov.in), State Govt. has setup a State Public Procurement Portal (SPPP) (www.sppp.raj.nic.in) to upload all kind of information related with public procurement and also made this portal accessible to the willing people as per directions of Finance Department (G&T). The details of information to be uploaded in SPPP are annexed as Annexure 'A'.

In this regard, to comply the direction of Government, Management has decided:-

1. Activities (as per annexure 'A') related with the tender/bid costing more than Rs. 1.00 lac shall also be uploaded for publication on SPPP along with uploading on RIICO website by Computer cell of the HO as per the compiled intimation of PR cell.
2. The tender costing more than Rs.25.00 lac shall also be uploaded for publication on SPPP along with www.eproc.rajasthan.gov.in by individual Unit offices and in compiled form on RIICO website by Computer cell of the HO as per the compiled intimation of PR cell as per existing practice.

This bears the approval of Financial Advisor and Managing Director.

This order shall come into force with immediate effect.

Annexure –‘A’

The following information related to Procurement is to be published in the SPPP Portal:-

1. Per-qualification document, bidder registration documents, bidding documents and any amendments, clarifications including those pursuant to pre-bid conference and corrigenda thereto.
2. Bid and bid award details of the Corporation.
3. List of bidders that presented bids including during pre-qualification or bidder registration as the case may be.
4. List of pre-qualified and registered bidders as the case may be.
5. List of bidders excluded u/s 25 of RPPP Act 2012 with reasons.
6. Decision u/s 38 and 39 of RPPP Act 2012 regarding appeals.
7. Details of successful bids their prices and particulars of bidders.
8. Particulars of bidders who have been debarred by the Corporation or State Government or a procuring entity together with the name of the procuring entity, cause for the debarment action and the period of debarment.
9. Categorized according to types and methods of bidding, product categories, types of Organizations and Organizations name.
