Terms & conditions:

A. Change in status of empanelment:

- The conditional/ provisional empanelment can be upgraded to final time bound empanelment once the final accreditation is issued by NABET.
- Meanwhile if NABET issues sector wise final accreditation or if there is any change
 in accreditation status, the empanelled consultants shall have to inform the same
 within 20 days to the Corporation along with the copy of letter issued from NABET,
 failing which the empanelment shall stand, cancelled.

B. Financial offer:

1. As and when required, the Corporation shall invite industrial area wise financial offer for carrying out EIA studies and undertaking work for Environmental Clearance (EC) from the concerned empanelled consultants. In this regard the tender documents (after payment of requisite tender fee) shall be sent through post and/or through e-mail to all the concerned empanelled consultants in the relevant category as mentioned above. The interested consultant can submit their financial bids alongwith cost of tender document and requisite earnest money.

After the offers are received by the last date mentioned in the tender document and post scrutiny; the L-1, among the offers received, shall be awarded the work order as per general procedure. Earnest money (EM) to the tune of 2% of expected tender amount, but not less than Rs. 20000/-, shall have to be deposited.

After approval of financial bid, work order shall be issued by respective unit offices after the approved consultant executes contract agreement and deposits a Performance Guarantee Amount (PGA) equivalent to 10% of work order amount after adjusting for EM. The PGA shall be refunded to the consultant at the time of making final payment to the consultant.

2. Mode of payment:

For case of 8(b) Category B (% of work order amount)

- 20% after submission of application with form 1/1A, pre-feasibility report and other required documents.
- 30% after presentation is made to the Committee (SEAC).
- 30% after receiving final decision of SEIAA Rajasthan regarding EC.



 20% after obtaining all requisite clearance from RSPCB such as consent to establish/operate.

For case of 7(c) Category A/B (% of work order amount)

- 20% after submission of application with form 1/1A, pre-feasibility report and other required documents to the appropriate Authority
- 20% after finalisation of ToR by the appropriate Authority
- 20% after submission of EIA report alongwith proceedings of public hearing to the appropriate Authority.
- 20% after receiving the final decision from the appropriate authority regarding EC.
- 20% after obtaining all requisite clearance from RSPCB such as consent to establish/operate.

3. Foreclosure

In the event of foreclosure, exclusively by the Corporation only, due to changes in the Act or any other reason, part payment (in a single installment) in accordance to following stages shall be allowed to the consultant alongwith refund of all the deposits of consultant lying with RIICO:

Stage 1: 10% of WO amount if work order is given: This includes the stage after the work order is placed and contract agreement is executed, and before the duly filled Form-1/Form-1 A along with Terms of Reference (TOR) is submitted to MoEF/SEAC/SEIAA

Stage 2: 20% of WO amount if approved/final TOR is received from MoEF/SEAC/SEIAA or the TOR is deemed to be approved otherwise as per Clause 7 II-(ii). This includes the stage after TOR is submitted to MoEF/SEIAA till the approved TOR is received.

Stage 3: 35% WO amount if the draft EIA report based on approved TOR is submitted to RIICO. This includes the stage after the approved TOR is received till the consultant submits the draft EIA report.

Stage 4: 50% of WO amount if the consultant has successfully got conducted the public hearing (if required) after stage 3 is achieved.

Stage 5: 70% of WO amount if the consultant has submitted the final EIA report and other documents to EAC/SEAC/SEIAA for appraisal and decision on EC. This includes the work after Stage 3/ Stage 4 (as required) and upto the final EIA report and other documents for appraisal and decision on EC is put forth to EAC/ SEIAA.

Note: In no case, the part payment in the event of foreclosure by the Corporation, shall be more than 70% of the work order amount. The part payment mentioned in the respective stages is inclusive of the amount of work executed in the preceding stages.

Non accreditation by NABET for the sector for which the work order has been awarded

In case the conditionally/provisionally accredited consultant comes to know after it has been awarded the work order by RIICO that it has failed to get accreditation in the specified sector (for which the work order was awarded) or the accreditation is cancelled by QCI/NABET, in such a case, the PGA shall be forfeited and work order shall be cancelled.

Ah

It is advised, therefore, only those consultants should submit their financial offer, that are certain that their NABET accreditation status shall not be revoked/cancelled/rejected during the duration of work order in the specific sector for which the work has been invited.

5. Reduced rate in case of delay

In the event of delay by the consultant over & above the approved duration of work order, an amount at the rate of 0.10% of work order amount per day shall be deducted from the final payment subjected to the terms & conditions specified in the contract agreement.

Apart from the above, other terms & conditions as per the financial offer and contract agreement shall be applicable.

This bears concurrence of Financial Advisor and approval of Managing Director.
