The Steel Furniture items shall be inspected as per RTPP Act & Rule 2013 S.O 135 Rule 32 in Sr. No 4 (f) (ii) "A standard recognized inspection agency of Rajasthan Small Industries Corporation shall inspect the quality of goods being supplied by them". The inspection agency/committee constituted by RSIC will inspect the goods and fix hologram/label on each item for quality assurance. The samples drawn on random basis will be got tested form standard recognized laboratory. Inspection charge shall be borne by supplier units these charges are not included in prices.
- 4. The above rates are inclusive of transportation charges upto consignees stores (purchasing department)
- 5. The rates shall be applicable on steel furniture items manufactured as per detailed technical specification of the tender document of RSIC.
- 6. The rates are valid for a period of One Year i.e upto <u>31.07.2021</u> or till re determined by the committee whichever is earlier.
- 7. The steel furniture items shall be supplied within 30 days or as per supply order of the supplier unit from the date of placing of the supply order failing which penalty as per GF&AR and RTPP Act & Rule 2013 shall be recovered.
