PRE-BID MEETING MINUTES

The following participated in the Pre-Bid Meeting held on 21.10.2021 at 12.30 PM in Board Room, RSIC, Udyog Bahwan, Tilak Marg, Jaipur regarding e-tender for Design and fabrication of Rajasthan Pavilion, IITF, Pragati Maidan, New Delhi (14 Nov. to 27 Nov., 2021):-

In the aforesaid meeting, following clarifications were made:-

- 1. The area of Rajasthan Pavilion has been reduced to 630 sq. mts. (35 mts. length x 18 mts. width) instead of 1000 sq. mts., as per enclosed layout plan.
- 2. Two govt. display areas/ galleries (Size: approx. 90 sq. mts. and approx. 30 sq. mts.) are to be prepared, as per enclosed layout plan.
- 3. Five theme areas/ galleries are to be prepared, as per enclosed layout plan and concept paper. It is clarified here that bidders are expected to add their own ideas, imaginations and creativity to the basic concept given with due consideration to the given theme, modernisation and progress of the State, sustainability and recycling etc. The same are to be shown in the presentations to be made before the committee.
- 4. 25 no. shops (each of 6 sq. mts. size with required infrastructure) are to be prepared instead of 40 shops, as per enclosed layout plan.
- 5. Touch screen kiosks are not required.
- 6. Normally taxi will be required on 12 hours basis for exhibition works only. Sometimes, it may be required beyond the 12 hours duration.
- 7. Only wooden structure is to be used. Octanorm / Maxima are not allowed.
- 8. Covid norms and provisions are to be followed.

- In case balance sheet/ accounts for the Financial Year 2020-21 are not ready, the bidder may submit provisional certificate issued by Chartered Accountant (with his seal and membership no.)
- 10. There will be no change in the financial years mentioned in the tender document that will be considered for technical qualification of the bidder.
- 11. Bidders may submit solvency certificate of Rs. 25 lacs or more.
- 12. Bidders may deposit the earnest money and tender fee through RTGS/ NEFT. However, processing fee is required to be paid through Demand Draft only. In case payment of earnest money/ tender fee is made through RTGS/NEFT, the bidder will have to submit proof and details of the successful payment along with the processing fee (through demand draft only) to the office of Director (Pavilion), RSIC, Udyog Bhawan, Tilak Marg, Jaipur latest by 12.00 noon of 27.10.2021 failing which his tender will not be considered.
- 13. The bidders will conceptualise design and infrastructure etc. to be used for the pavilion as per the theme, layout plan and scope of work, for best display of the State. The same will be mentioned in detail by the bidder during his presentation.

14. All bidders who are invited to make their presentation will be required to submit one soft copy of their presentations with complete details and specifications of material to be used, immediately after their presentation. Submission of hard copy will be highly appreciated.








