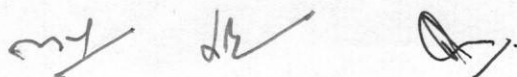

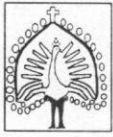

Mtr. area. As the export/import trade at ICD-Jodhpur has been increased upto 3 times. Resulting it leads to the shortage of working space for movement of containers, heavy vehicles etc.

Detailed Scope of Work:

The Scope of work for Consultancy firm for making DPR should be as follows:-

1. Examination & blue print of site plan for additional Inland container depot at Tanawara vill. Near salawas Railway station Jodhpur.
2. Evaluation of infrastructure required for ICD Jodhpur.
3. Preparation of drawing & detailed specification for new ICD by qualified architect.
4. Preparation of detailed project report as per requirement of RSIC
5. Making presentations and to follow up with Govt. of India for release of funds under TIES scheme after submission of proposal by RSIC.
6. Visit to Government of India offices as and when required.
7. Amendments and submission of revised proposals if required.
8. Supervision of civil works and verification of works by qualified Civil Engineer/ Architect.

Eligibility Criteria

The agencies/firm intending to bid shall fulfil the minimum following qualification criteria:-

1. The bidders must be a Rajasthan State based consultancy having similar experiences of consultancy in the relevant field.
2. Consultancy company must have experience of providing consultancy services for preparing DPR's for Industrial areas, ICD's, Warehouses etc. and understanding of the Rajasthan state working will be preferred.
3. The participating agency/firm should not be blacklisted /debarred by any Govt. or semi Govt. The agency shall specifically mention about any litigation presently going on with any department.
4. The party will submit the self-attested certificate in this regard.
5. The bidder must be ISO 9001: 2015, ISO 14001: 2015 and ISO 27000:2013 certified.
6. The bidder in case MSME, must have NSIC registration and MSME Udhyaam Adhaar for scope of consultancy services.

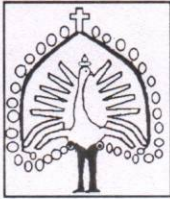
