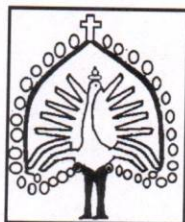

Brief Profile:

The Corporation was incorporated on 3rd June, 1961 under the Companies Act, 1956. This is about 60 years old fully owned Public Ltd. Company of Govt. of Rajasthan.

- ❖ It plays a major role in promoting the handicrafts produced in the state. The Corporation assists the craftsmen by providing them the designs and facilities for marketing of the products. Rajasthali, its showroom, is an exclusive sales outlet with branches throughout India.
- ❖ RSIC provides raw materials – Iron & Steel and Coal to the SSI units.
- ❖ RSIC facilitates Trade industry by providing Export Infrastructure Services through its Inland Container Depot (ICDs) at Jaipur & Jodhpur as well as Air Cargo Complex at Sanganer Airport, Jaipur for International Export- Import Cargo.
- ❖ The Corporation is providing marketing assistance to the SSI units for its products – Steel Furniture, Tent & Tarpaulins, Desert Coolers, Polythene Bags, Barbed Wire and Angle Iron Posts.

The RAJSICO has started Rajasthali Mall at MI Road, Ajmeri Gate, Jaipur in 2005. The RAJSICO is facilitating handicraft artisans of Rajasthan State by providing space in their Rajasthali emporiums by mode of QST counters and in GoA scheme.

Since the date of establishment of Rajasthali emporium Jaipur, there had been no major renovation and rehabilitation work done by RSIC. It requires several interior design changes and civil work, electrification, CCTV cameras including repairs etc. according to the new modern requirements of market to attract the Indian as well as foreign customers. The above renovation and changing work of Rajasthali emporium Jaipur require Design Basic Report, BOQ (G-Schedule) and estimation coordination with contractor etc. by a qualified and experienced architect.

Scope of Work:

The scope of work of Rajasthali Emporium and Rajasthali Mall will be as mentioned hereunder:

(A) Rajasthali Emporium

The Renovation of Rajasthali Emporium Building will be done under the technical guidance and supervision of technical consultant. The scope of work will include :

1. Condition assessment of Building and preparation of condition assessment report.
2. Design Basis Report
DBR for Design intervention and proposal for renovation works.
3. BOQ and Estimation
Detailed estimates for renovation work.
4. Preparation of detailed specification of all renovation work.
5. Coordination for appointment of contractor
6. Regular site supervision as required during renovation work to ensure work is under taking as per laid down specification.
7. Verification of works done by the contractor.

(B) Rajasthali Mall

1. Designing working plan for improved parking.
2. Designing cafeteria area in Rajasthali Mall.



Eligibility Criteria

The agencies/firm intending to bid shall fulfil the minimum following qualification criteria:-

1. The bidder must be a qualified architect having similar experience of at least 10 years in the relevant field.
2. Bidder must have experience of providing technical consultancy services for emporium/Mall of at least 10,000 sq ft area for Rajasthan Govt. Department/ Rajasthan Govt. undertaking..
3. The participating agency/firm should not be blacklisted /debarred by any Govt. or semi Govt. The agency shall specifically mention about any litigation presently going on with any department, if any and enclose an undertaking in this regard.
4. The average annual turnover must be at least 15 lacks in last three years (FY 2018-19, 2019-20, 2020-21). Bidder must enclosed copy of IT returns/ audited balance sheet for this purpose.
5. The bidder must have to submit the copy of GST license No. & PAN.

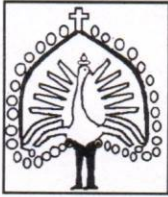
