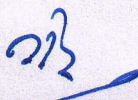

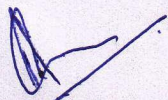
In the aforesaid meeting, the following clarifications were made:-

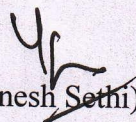
1. Solvency certificate should be from a national or scheduled bank only.
2. For GST returns, Service Tax returns will be considered for the period for which GST was not made applicable by the Government
3. Power of Attorney will be required if the person signing the bid is other than Proprietor/ Owner/ Director of the bidding firm/company. For Proprietor/ Owner/ Director self declaration on the letter head of company/ firm will be considered.
4. Rough layout plan of Rajasthan Pavillion has been enclosed for giving broad idea of the space available to the bidders.
5. The original instruments of Earnest Money, Tender Fee & RSIL processing fee should be deposited in RSIC Head Office latest by 12.00 noon of 30.10.2019

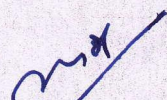

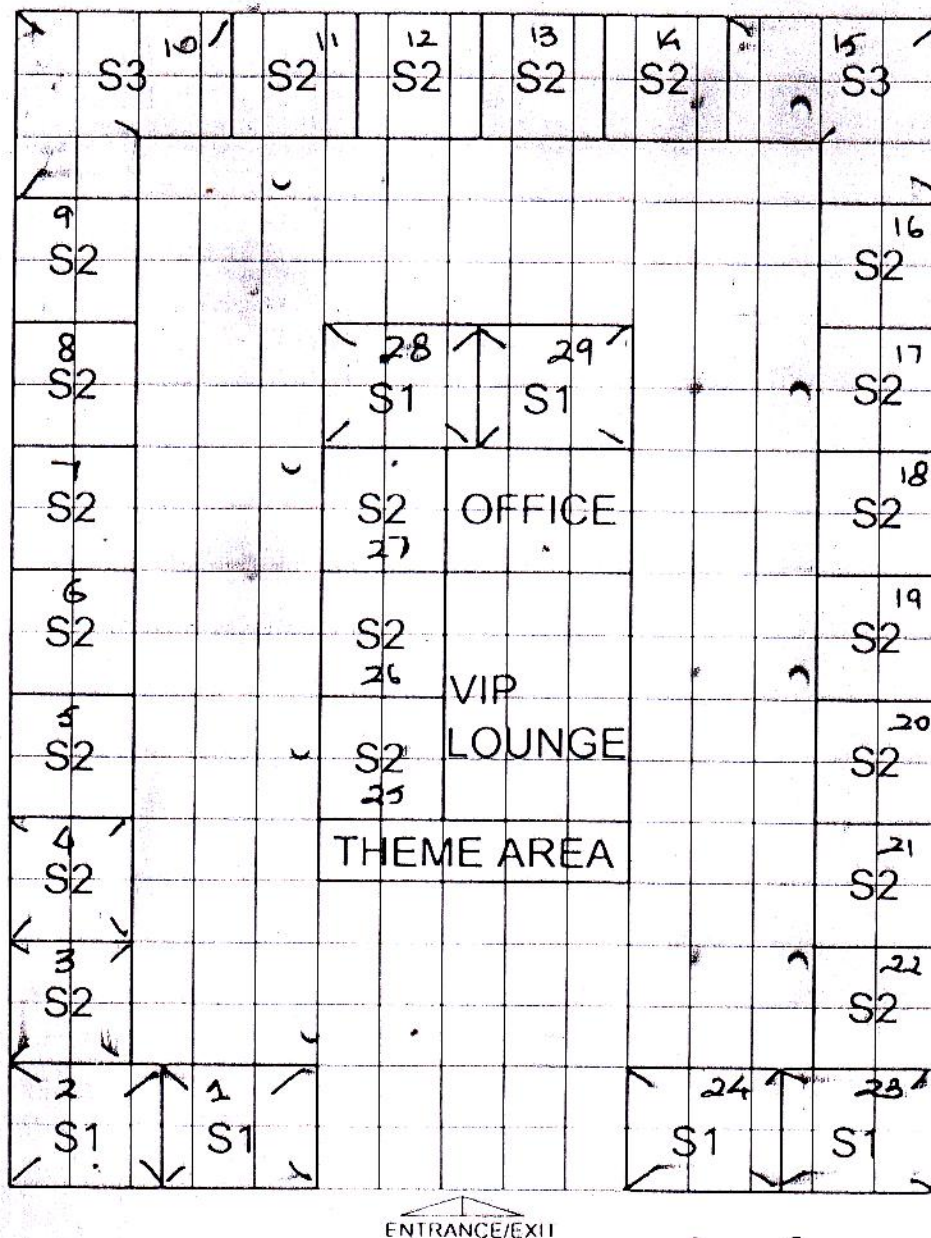
6. All the documents uploaded by bidder should be digitally signed by his authorized signatory.
