All the Developers, Investors & Agencies who intend to establish Green Hydrogen Generation Project or Green Hydrogen Production plant through Renewable Energy sources in Rajasthan are required to get registered with the Government of Rajasthan.

RRECL would be the Nodal Agency for registration of Green Hydrogen Projects. The Green Hydrogen Policy is under process and till issuance of Policy, the registration of Green Hydrogen Project will be started on provisional basis. The Developer/Investors/Agencies may apply offline mode to RRECL by submitting an application in the prescribed form (Enclosed at Annexure-1) along with the requisite documents and Registration charge. The Registration charges details are as under:

Each Developer/ Power Producer will deposit following non-refundable registration charge for RE Capacity with RREC (For 1 KTPA Green Hydrogen Plant, maximum 25 MW RE capacity will be considered).

S.No.	Project RE Capacity	Rate (Registration Charge)
1	For Project ≤ 100 MW capacity	Rs 30,000/- per MW
2	For Projects > 100 MW and ≤ 500 MW capacity	30 Lac +Rs 2.5 lac per 100 MW beyond 100 MW or part thereof
3	For Projects > 500 MW and ≤ 1000 MW capacity	40 Lac +Rs.2 lac per 100 MW beyond 500 MW or part thereof
4	For Projects > 1000 MW capacity	50 Lac +Rs.1 lac per 100 MW beyond 1000 MW or part thereof subject to maximum Rs. 1 Crore per project

The GST as applicable, shall be payable in addition to the registration charges. The Bank details of RREC enclosed at Annexure-2.

Note: Further, after issuance of Green Hydrogen Policy by the State Government, the registration charge if found in excess in the final policy, shall be recoverable from the applicant.
