NOTIFICATION

The State Government vide Notification No. F. 20(10)Energy/09 dated 26.02.2010 has notified Policy for Promoting Generation of Electricity from Biomass, 2010. In the said policy, sub clause 15.1.2, 15.2 and 17.9.2 are hereby replaced with immediate effect as under: -

15.1.2 Finalization of land, power evacuation plan and availability of water- within 8 months from the date of issue of project registration number (PRN).

15.2 Power Producer shall commission the Biomass Power Project within 36 months from the date of approval of the Project.

Provided that extension in time schedule may be granted by the SLEC on case to case basis after depositing penalty amount as under: -

(a)	For delay up to 3months	Rs. 25000.00 per MW
(b)	For delay up to 6 months	Rs. 50000.00 per MW
(c)	For delay up to 9 months	Rs. 75000.00 per MW
(d)	For delay up to 15 months	Rs. 100000.00 per MW
(e)	For delay up to 24 months	Rs. 125000.00 per MW

17.9.2 The responsibility of cutting/uprooting, **loading/unloading** and transporting of Biomass produce from plantation site to the plant site **and chipping** shall rest with the Biomass Power Producer. The fuel cost prescribed by RERC does not provide for break-up of cutting/uprooting, **loading/unloading**, transportation, **chipping** and Biomass cost. Therefore, 65% of the fuel cost prescribed by RERC shall be taken as cost towards cutting/uprooting, **loading/unloading**, transportation **and chipping** on lump sum basis. However, in case RERC determines cost of cutting/uprooting, **loading/unloading**, transportation **and chipping** of Biomass separately in the tariff petition, the same shall be applicable with prospective effect. Per tonne price of Biomass at plantation site shall be determined by deducting cost of cutting/uprooting, **loading/unloading**, transportation **and chipping** from per tonne fuel price prescribed by RERC.

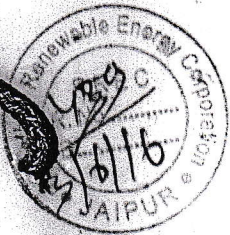
