प्रायः यह देखा गया है कि वनभूमि प्रत्यावर्तन के प्रकरणों में प्रयोक्ता अभिकरणों द्वारा प्रस्तावों के साथ वनाधिकार अधिनियम, 2006 के अन्तर्गत जिला कलेक्टर द्वारा जारी प्रमाण पत्र भारत सरकार, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, नई दिल्ली द्वारा निर्धारित प्रपत्रों में प्रस्तुत नहीं किये जाते हैं जबकि भारत सरकार के पत्रांक 11-9/98-एफसी (पार्ट) दि. 5.7.2013 द्वारा जिला कलेक्टर्स के प्रमाण पत्रों हेतु लीनियर प्रोजेक्ट्स हेतु फॉर्म नं. 1 तथा लीनियर प्रोजेक्ट्स के अलावा अन्य प्रोजेक्ट्स हेतु फॉर्म नं. 2 पर पृथक-पृथक निर्धारित प्रारूप पर प्रमाण पत्र प्रेषित करने हेतु निर्देश प्राप्त हुए थे।

इस कार्यालय के सम संख्यक पत्रांक 7139 दि. 5.8.2013 द्वारा समस्त वनाधिकारीगण/जिला कलेक्टर्स एवं प्रयोक्ता अभिकरणों के विभागाध्याक्षों को प्रेषित कर भारत सरकार के दिशा-निर्देशानुसार उक्तानुसार निर्धारित प्रपत्रों पर ही वनाधिकार अधिनियम, 2006 के अन्तर्गत जारी प्रमाण पत्र प्रेषित करने हेतु लिखा जा चुका है।

अतः भारत सरकार द्वारा लीनियर प्रोजेक्ट्स तथा नॉन-लीनियर प्रोजेक्ट्स हेतु निर्धारित प्रारूप की प्रति पुनः संलग्न कर निर्देश दिये जाते हैं कि भविष्य में वनभूमि प्रत्यावर्तन हेतु प्रस्ताव के साथ उक्तानुसार निर्धारित प्रारूप (प्रोजेक्ट अनुसार) पर ही जिला कलेक्टर का प्रमाण पत्र संलग्न कर प्रेषित किया जाना सुनिश्चित करें। यहां उल्लेख है कि उक्तानुसार निर्धारित प्रपत्रों के प्रारूप विभागीय वेबसाइट **rajforest.nic.in - departmental wings - forest conservation - order & circulars** पर भी प्रदर्शित कर दिया गया है।

- (c) the each of concerned Gram Sabha(s), has certified that all formalities/processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the gram sabha of village(s) is enclosed as annexureto annexure.....

- (d) the discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present;
 - (e) the diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it;
 - (f) the rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA.
