Jaipur, August 4, 1980.

S.O. 50.—In exercise of powers conferred under sub-section (1) of section 18 of the Wild Life (Protection) Act, 1972 (Central Act No. 53 of 1972) the State Government hereby declares the areas, situated in Jaisalmer and Barmer districts, as a Sanctuary from the date of issue of this notification. The description of the boundaries of this sanctuary is as follows :—
