EXECUTIVE SUMMARY

Background: The Rajasthan Secondary Towns Development Sector Project (RSTDSP) is the fourth phase of investment projects financed by the Asian Development Bank (ADB) and implemented by the Rajasthan Urban Drinking Water Sewerage and Infrastructure Corporation Limited-Externally Aided Projects (RUDSICO-EAP), previously known as Rajasthan Urban Infrastructure Development Project (RUIDP). RSTDSP seeks to improve water supply, sewerage, and other infrastructure services in secondary towns of Rajasthan with populations ranging from 20,000-110,000 through a sector loan modality. The project is aligned with the following impact(s): (i) access to potable, affordable, reliable, equitable, and environmentally sustainable drinking water supply in all urban areas of Raiasthan improved; and (ii) the health status of the urban population, especially the poor and under-privileged improved through improvements in sewerage systems of sub-project towns (iii) improvements in other infrastructure services of some towns. Under RSTDSP, work is in progress in 14 project towns. RSTDSP will support the ongoing efforts of the Government of Rajasthan towards improving the sewerage conditions of 13 towns through undertaking Faecal Sludge and Septage Management (FSSM) works. The Government of Rajasthan has decided to take up implementation of Water Supply, Sewerage, Drainage, Faecal Sludge and Septage Management (FSSM) and other city improvement works, including city beautification works in about 23 towns under the additional financing of \$200 million from Asian Development Bank (ADB). Department of Economic Affairs (DEA), Government of India has agreed to additional financing of these new projects. Conservation and development of heritage sites of Bundi town is one of the subprojects proposed under the investment component of RSTDSP-additional financing.

Bundi is an important tourist destination in the state of Rajasthan. The objective of the subproject includes: (i) improving infrastructural facilities and helping create durable public assets and quality-oriented services in cities to inculcate and boost the healthy environment, (ii) improving Nawal Sagar Park and surrounding area to create a tourist destination and city-level park for Bundi residents. (iii) conservation of important *Baoris* (*step-wells*) and *Chatris* (domeshaped pavilions (iv) enhance public-private-partnership for infrastructural development, and (v) enhance tourism and economic activities in Bundi district.

Subproject Description: Bundi is one of the towns selected under additional financing of RSTDSP and key components are: (i) beautification of Nawal Sagar Lake and Nawal Sagar Park: (a) cleaning of Nawal Sagar lake intercepting of drain into Nawal Sagar (b) enhancing the capacity of Nawal Sagar lake (c) beautification of the two sides of lake edge (d) development of the entrance plaza (e) development of the interconnection of three different parks into one (f) development of alternate route for the public use (g) interconnecting the park and Nawal Sagar lake, redesigning of road between the park and lake into the promenade (h) development of food court, public utilities and parking spaces etc.; (ii) conservation of two Baoris- Naru ki Baori (step well) and Nagar and Sagar Baori (step well) (a) cleaning of baoris (b) repair and restoration of the Baoris (iii) conservation and façade lighting of city gates: Chogan Gate 1st and 2nd, Meera Gate, Khoja Gate, Lanka Gate; (iv) conservation and restoration of nine Chatris: (Abhaynath Mahadev Chatri, Sheriyo ki Chatri, Nawal Sagar Chatri, Champa Bagh Chatri, Manohar Bawri Chatri, Nagar-Sagar Chatri, Ghodiwale Baba ki Chatri, Jait Sagar Smriti Kunj Chatri and Nasiya ji ki Chatri).

Scope of Land Acquisition and Resettlement: Land acquisition is not envisaged for the construction and execution of any of the proposed subproject components. Nawal Sagar, Nawal Sagar Park, *Baoris*- Naru ki Baori and Nagar and Sagar *Baori*, conservation and façade lighting of all the proposed city gates Chogan Gate 1st and 2nd, Meera Gate, Khoja Gate, Lanka Gate

and conservation and restoration of 09 *Chatris*: (Abhaynath Mahadev *Chatri*, Sheriyo ki *Chatri*, Nawal Sagar *Chatri*, Champa Bagh *Chatri*, Manohar Bawri *Chatri*, Nagar-Sagar *Chatri*, Ghodiwale Baba ki *Chatri*, Jait Sagar Smriti Kunj *Chatri* and Nasiya ji ki *Chatri*) are under the possession of Nagar Parishad (Municipality), Bundi. No objection from Nagar Parishad, Bundi has been obtained for the proposed works. Land revenue records of Nawal Sagar Lake and Nawal Sagar Park is attached. Land revenue documents for rest of the proposed sites like gates, *Baoris* (*step wells*), *Chatris* will be obtained and same will be appended in updated resettlement plan prior to start of civil works.

Involuntary Resettlement Impact: The involuntary resettlement impacts assessed through subproject census and 100% socio economic survey based on detailed design and include loss of livelihood impacts. Implementation of the subproject will impact 27 vendors/shops (all males) comprising 170 family members (91 males and 79 females) under aforesaid proposed components. Out of these 27 vendors/shops; (i) 7 vendors (selling milk, juice, fast-food, ice cream) are operating their business outside the Nawal Sagar Park (37 family members consisting of 19 males and 18 females) all of which are envisaged to face temporary income loss, and (ii) temporary livelihood impacts are envisaged on 20 shopkeepers/vendors (133 family members consisting of 72 males and 61 females) during restoration and replacement of damaged parts of city gates (Chogan Gates, Lanka Gate and Meera Gate).

For the 7 vendors operating outside the Nawal Sagar Park, an alternate site 350 meter away from their current location has been identified for their continued business activity. These make-shift structure/pushcarts can be moved from their current location to the alternate site. Construction of one cafeteria at Nawal Sagar Park is part of the project and the vendor selling milk (authorized milk parlor) will be accommodated / provided shop with secure tenure and lease renewal facility withing the cafeteria; based on mutually agreeable terms and conditions with the Bundi Nagar Parishad i.e. Municipality. This arrangement will elevate his status from non-titled vendor to a vendor with recognizable rights to the property. The vendor selling milk is operating from a movable pre-fabricated structure. The structure was provided to the vendor by Rajasthan Cooperative Dairy Federation (SARAS) and the vendor will be able to return the structure upon provided with the shop at the cafeteria. The rest of the 6 vendors have pushcarts. Hence, the impacts are limited to livelihood loss and no loss of structure is envisaged. The remaining 6 vendors (operating outside Nawal Sagar Park) will be allowed back in their original place of business upon execution of work. During construction, project will assist these vendors for shifting to the new identified site for continued business activity, if required.

During restoration and replacement of damaged parts of city gates (Chogan Gates, Lanka Gate and Meera Gate), temporary livelihood impacts is also envisaged on 20 shopkeepers (133 family members). Out of 20 potentially affected persons, 13 have permanent shops (authorized shops, registered in Nagar Parishad, Bundi), 05 have small cabins and 01 is having a pushcart and 1 is using the road ROW for conducting business. All the shops including cabin and vendor are adjacent to the gates that is proposed for repair and façade works. Category of shops gates wise is presented below:

As per discussion with design team, it was confirmed that scaffolds will be used (BoQ items) during restoration of gates to avoid/minimize the impacts of commercial activities during the construction period. However, to mitigate any potential impacts (temporary loss of income) on shops during subproject implementation, adequate budget is proposed. In discussion with technical team 30 days' compensation for temporary livelihood losses is considered in the resettlement budget for 26 vendors/shopkeepers facing temporary livelihood impacts due to access disruption. The milk parlor (1 vendor) currently operating on the roadside from a movable structure, will be (i) allowed alternate space to operate during the period of construction and (ii) accommodated / provided a shop within the proposed cafeteria with secure tenure elevating his status from non-titled vendor to a vendor with recognizable rights to the property. These provisions are adequate to mitigate his loss and provide for continued business opportunity at the same location (the cafeteria is proposed at the Nawal Sager Park space). Shifting assistance (two times – i. for moving to the alternate location and ii. for moving into the proposed cafeteria - as the person will be required to shift materials and wares twice, once to the temporary relocation site and another time, to the shop proposed to be constructed by the project) will be provided to the 1 vendor (milk parlor). The impact on the 27 vendors is temporary in nature and budget provisions are provided accordingly as per the entitlement matrix of the project. Based on data from the socio-economic survey, out of 27 affected households (170 family members), 3.70% (1 affected household consisting of 4 members – 2 males and 2 females) of the affected households belongs to scheduled caste category (vulnerable category). None of the potential affected persons are from scheduled tribe category nor there is presence of any women headed households within the affected households.

After assessment of sites, contractor shall prepare works plan including details, how to implement the proposed works including repair and façade works of gates including subproject specific environmental management plan. After submission of works plan, reassessment will be undertaken by safeguard team and draft resettlement plan will be update and same shall be shared to ADB for approval.

Consultation and Disclosure: Goals and the objectives of the project have been disclosed to stakeholders (including beneficiaries, affected persons, elected representatives, and institutional stakeholders) through consultation meetings. A total of 117 persons (100 males, 17 females) were consulted. Additional consultations will be conducted and will be continued throughout the subproject implementation. A leaflet in the local language (Hindi) containing the project scope, types of impacts and entitlement, and grievance redress mechanism was circulated to stakeholders as well as potential affected persons. A hard copy of the summaries (draft and final) will also be made available at government offices, and complete approved documents will be uploaded to the project management unit (PMU) and ADB websites.

Grievance Redress Mechanism: A project-specific, three-tier grievance redress mechanism

(GRM) covers both environment and social issues. The GRM established under tranche 1 of RSTDSP was found to be effective and will be adopted. The GRM will aim to provide a time-bound and transparent mechanism to voice and resolve social and environmental concerns linked to the project

Resettlement Budget and Financing Plan: The resettlement budget for conservation and development of heritage sites of Bundi town subproject components includes compensation for temporary loss of income, resettlement assistance and assistance to vulnerable households as outlined in the entitlement matrix, and 20% contingency provision, in total amounting to ₹1,835,652 (INR 1.83 million). The Superintending Engineer / Executive Engineer of PIU will issue sanction orders for compensation payment to affected persons, which shall be released through electronic clearance service/National Electronic Fund Transfer (ECS/NEFT) transaction from the bank through the concerned Treasury of the state administration. Community awareness and public participation consultants (CAPPC) will facilitate the disbursement process and open bank accounts for the affected persons who do not have bank accounts.

Institutional Setup: The Local Self Government Department (LSGD), Government of Rajasthan (GOR) will be the executing agency (EA) of the project, and LSGD will be responsible for overall strategic approvals, guidance, and monitoring of the project. Rajasthan Urban Drinking Water Sewerage and Infrastructure Corporation Limited (RUDSICO) will be the project's implementing agency (IA). The Project Management Unit (PMU) is housed in the Externally Aided Projects division of RUDSICO (RUDSICO – EAP). PIU/PMU will closely monitor resettlement plan implementation. Monitoring reports prepared by PIU will be compiled by PMU on a semi-annual basis for its due submission to ADB.

I. INTRODUCTION

- 2. Bundi is a district headquarters and historical and tourism town of Rajasthan state. Bundi is located 212 km away from the State Capital, Jaipur. Bundi Town is between 25044' N latitude and 75064' E longitude, and the Chambal River flows approximately 32 km from the town. The total area of Bundi Town is 53.97 km², comprising 60 municipal wards. Bundi is well connected with the important cities of Rajasthan through a network of roads. The population of Bundi Town has increased rapidly during the past 50 years. The city had a population of 26,478 in 1961, while as per the 2011 census, the population has increased to 104,919. Thus, the city's population has increased annually by 1.58%.
- 3. There are so many historical tourist sites in Bundi town. Nawal Sagar Lake and Park will impact the destination of domestic and other international tourists coming to the Bundi and Hadoti regions. Nawal Sagar Lake is one of Bundi's most important tourist attractions. Different *baoris* (stepwells) surround this lake from all sides. There is a temple of Lord Varuna, i.e., the Aryan God of water, situated at the center of this lake and attracts many worshippers. Nawal Sagar Lake, surrounded by hillocks, is very well connected from Jaipur through Kota by-pass Road and is also well connected with Bundi Town. Bundi has more than 50 old step wells, considered one of the best water collection methods. Bundi is famous for its old heritage structures, including gates *Baoris* and *Chatris*.
- 4. Average monthly visitors to Bundi vary from 1289 to 4957 from January to December. The peak tourist season is from October to January, averaging 3156 monthly. After the Covid-19 pandemic, mostly local visitors come for a picnic at Nawal Sagar, and some foreign tourists also visit Nawal Sagar who come to Bundi. The number of visitors increases on weekends.

5. Bundi is an important tourist destination in the state of Rajasthan. Implementing the subproject will improve the tourism scenario of the town and will provide a new recreational avenue to the local public and a new tourist spot. This will also improve livability in Bundi town. This subproject aims to improve economic development by providing infrastructure and services through city beautification. Improving the quality of life and, thereby, the effective contribution of beneficiary people in economic activity is expected. The objective of the subproject includes (i) Improving infrastructural facilities and helping create durable public assets and quality-oriented services in the town to inculcate and boost the healthy environment, (ii) Improving Nawal Sagar Park and surrounding area to create a tourist destination and city level park for Bundi residents, (iii) Conservation of important *Baoris* (step-well) and Chatris, (iv) Enhance public-private-partnership for infrastructural development, and (v) Enhance tourism and economic activities in Bundi district.

B. Existing Condition of Proposed Sites

6. **Nagar Sagar Lake**: Nawal Sagar Lake is not currently in good condition. The lake's perimeters display fractures, while the plaster and paint along the lake boundary and pathways have sustained varying degrees of damage. In addition, the encircling road of the lake becomes muddy during rainfall. Furthermore, the lake water has become contaminated, with debris accumulating on its surface.



7. **Nawal Sagar Park**: Nawal Sagar Park lacks proper designated parking facilities. On average, around 20-30 two-wheelers and 3-5 four-wheelers visit the park. There is no provision for water supply and restroom amenities within the park premises. The area also suffers from a lack of informative signage and directional guidance. Crucial aspects such as demarcation and information panels are notably absent and need to be installed. While the garden does have benches, other seating arrangements are absent. Additionally, sections of the park's boundary wall have been completely demolished.

8. **Present scenario of** *Baoris* (*step wells*) - Naru Ki *Baori* and Nagar and Sagar Baoris /Kund (water body): A lot of work is required to be undertaken in both Baoris. The plaster and paint have deteriorated, the intricate ornamental designs in the architecture have been dismantled, black patches have formed on the walls, and vegetation has taken root on the steps and *Baori* walls.


Figure 3: Photographs of Baoris

9. **Present scenario of gates**: Bundi is famous for its old heritage structures, including gates *Baoris* and *Chatris*. Presently they are in depleted and deteriorated condition. The plaster and paint have suffered depletion; some areas have been damaged, algae growth can be observed, and seepage, dampness, and watermarks have developed. Additionally, the damage is noticeable on the columns and inner walls of the gates and surrounding area.


Figure 4: Photographs of Gates

10. **Present scenario of** *Chatris*: Bundi is home to approximately 105 *Chatris*, and most are depleted and deteriorated. Nine major *Chatris* among them are considered for conservation. The plaster and paint have experiences erosion, *Chatri* projections and Kalash have been disassembled, the platform floor has cracked, algae patches have been formed, and dampness has developed on the *Chatri* dome and column. Additionally, there is the growth of vegetation on the steps of the Chatri platforms.





C. Subproject Components

11. As a part of the city development and beautification scheme, on the basis of stakeholder consultations and field studies, the following are the proposed works: (i) beautification of Nawal Sagar Lake and Nawal Sagar Park: (a) cleaning of Nawal Sagar Lake, intercepting of drain into Nawal Sagar, (b) enhancing the capacity of Nawal Sagar Lake, (c) beautification of the two sides of lake edge, (d) development of the entrance plaza, (e) development of the interconnection of three different parks into one, (f) development of alternate route for public use, (g) interconnecting the park and Nawal Sagar Lake, redesigning of road between the park and lake into the promenade, (h) development of food court, public utilities and parking spaces etc; (ii) conservation of two *Baoris*- Naru ki *Baori* and Nagar and Sagar *Baori* (a) cleaning of *Baoris* (b) repair and restoration of the *Baoris*; and (iii) conservation and Façade lighting of city gates: Chogan Gates-1 and 2, Meera Gate, Khoja Gate, Lanka Gate, (iv) conservation and restoration of 09 *Chatris*: (Abhaynath Mahadev *Chatri*, Sheriyo ki *Chatri*, Nawal Sagar *Chatri*, Champa Bagh *Chatri*, Manohar Bawri *Chatri*, Nagar-Sagar *Chatri*, Ghodiwale Baba ki *Chatri*, Jait Sagar Smriti Kunj *Chatri* and Nasiya ji ki *Chatri*). The scope of work for the subproject is presented in Table 2 below.






Figure 8: Proposed Plan of Nawal Sagar Park




Figure 9: Proposed Plan at Naru Ki *Baori*





Figure 10: Proposed Plan at Nagar -Sagar Kund/Baori





Figure 12: Proposed Plan at Chogan Gate-2




Figure 13: Proposed Plan at Meera Gate




Figure 14: Proposed Plan at Lanka Gate




Figure 15: Proposed Plan at Khoja Gate




Figure 16: Proposed Plan at *Chatri*s

12. Measures to Avoid and Minimize Involuntary Resettlement: In order to avoid and minimize involuntary resettlement impacts, all the works are proposed within the existing campus and premises of the Nawal Sagar Lake and Park, Baoris, and city gates, etc., which are under the possession of Nagar Parishad, Bundi. The following measures would be adopted to mitigate loss of livelihood during the execution of civil works: (i) provision of alternate space within the/ close to vicinity of their current location (Nawal Sagar Park) for continued business activity of 7 vendors: (ii) provision of 1 shop in the newly proposed cafeteria (for the road-side vendor having milk booth) under the project after completion and (iii) install temporary signage indicating the location of alternate location provisioned for the 7 road side vendors near Nawal Sagar Park and (iv) provision of compensation as per the resettlement framework. In addition measures to be taken up by contractor to avoid/mitigate economic impacts include:(a) announcement of proposed civil works in advance (to enable shop owners to stock up and remain unaffected if goods vehicles are unable to reach them during construction); (b) minimizing construction period to the extent possible; (c) assistance to mobile vendors operating through carts and kiosks, if any, present during construction, to shift to a nearby location for continued economic activity; (d) signage with project details and contact details for grievance redress. These measures (a to d) will be part of the contract and will be implemented with careful monitoring by the concerned PIU and CMSC. Further, the design team confirmed that scaffolds will be used (BoQ items) during restoration of gates to avoid/minimize the impacts of commercial activities during the construction period.

D. Objectives of the Resettlement Plan

- 13. This draft resettlement plan is prepared for the proposed conservation and development of heritage sites in Bundi town under RSTDSP. It is based on a 100% socio-economic survey of potentially affected persons. It addresses the potential involuntary resettlement impacts of the proposed subproject components based on a detailed project report and is consistent with the agreed resettlement framework for RSTDSP,² prepared in accordance with national laws and ADB SPS, 2009.³
- 14. This draft resettlement plan is prepared in accordance with ADB SPS, 2009 requirements for involuntary resettlement category B projects and to meet the following objectives:
 - (i) to describe the identified scope and extent of land acquisition and involuntary resettlement impacts because of identified project components and address them through appropriate recommendations and mitigation measures in the resettlement plan;
 - (ii) to present the socio-economic profile of the population in the project area, identify social impacts, including impacts on the poor and vulnerable, and the needs and priorities of different sections of the population, including women, poor and vulnerable:
 - (iii) to describe the likely economic impacts and identified livelihood risks of the proposed project components;
 - (iv) to describe the process undertaken during project design to engage stakeholders and the planned information disclosure measures and the process for carrying out consultation with affected people and facilitating their participation during project implementation;

- (v) to establish a framework for grievance redressal for affected persons that is appropriate to the local context, in consultation with stakeholders;
- (vi) to describe the applicable national and local legal framework for the project, and define the involuntary resettlement policy principles applicable to the project;
- (vii) to define entitlements of affected persons, and assistance and benefits available under the project;
- (viii) to present a budget for resettlement and define institutional arrangements, implementation responsibilities, and implementation schedule for resettlement implementation; and
- (ix) to describe the monitoring mechanism that will be used to monitor resettlement plan implementation.

II. SCOPE OF LAND ACQUISITION AND INVOLUNTARY RESETTLEMENT

A. Land Acquisition and Involuntary Resettlement

- 15. The construction of the proposed subproject components will not require land acquisition as the works will be carried out within the government-owned land in possession with Nagar Parishad (municipality) and necessary no-objection certificates have been obtained. However, the subproject will cause a livelihood impact on 27 business establishments (shops and vendors), including one shop (authorized milk parlor in Nawal Sagar Park) who will be repositioned in the new shop in the same locality/vicinity with the same access to the same clientele and business opportunities as pre-project stage. , while the 26 businesses are encountering temporary livelihood impacts including temporary impact on access of 13 permanent shops.
- 16. A summary table on the land availability, ownership status, dimensions, and photographs is attached as **Appendix 1.** Nawal Sagar Lake, Nawal Sagar Park, *Baoris* Naru ki *Baori* and Nagar and Sagar *Baori*, all the proposed city gates Chogan Gate 1 and 2, Meera Gate, Khoja Gate, Lanka Gate and 09 *Chatris*: (Abhaynath Mahadev *Chatri*, Sheriyo ki *Chatri*, Nawal Sagar *Chatri*, Champa Bagh *Chatri*, Manohar Bawri *Chatri*, Nagar-Sagar *Chatri*, Ghodiwale Baba ki *Chatri*, Jait Sagar Smriti Kunj *Chatri* and Nasiya ji ki *Chatri*) are under the possession of Nagar Parishad, Bundi and necessary no objection to carry the conservation and redevelopment works at these sites have been issued by them (**Appendix 2**). The land records of Nawal Sagar Lake and Nawal Sagar Park are attached in **Appendix 3 and 4**, respectively. Land revenue documents for the rest of the proposed sites like gates, Baoris (step wells), Chatris (canopy) will be obtained and same will be appended in the updated resettlement plan before the civil works start. The Google map of proposed locations is attached through **Appendix 5 to 20**.

- 17. **Involuntary Resettlement Impact:** The involuntary resettlement impacts assessed through subproject census and 100% socio economic survey based on detailed design and include loss of livelihood impacts. Implementation of subproject will impact 27 vendors (170 family members consisting of 91 males and 79 females). Out of these 27 vendors/shops; (i) 7 vendors (selling milk, juice, fast-food, ice cream) are operating their business outside the Nawal Sagar Park (37 family members consisting of 19 males and 18 females); of which all are envisaged to face temporary income loss, and (ii) temporary livelihood impacts are envisaged on 20 shopkeepers/vendors (133 family members consisting of 72 males and 61 females) during restoration and replacement of damaged parts of city gates (Chogan Gates, Lanka Gate and Meera Gate).
- 18. **Resettlement impacts Nawal Sagar Park:** During development of pathways inside and outside the Nawal Sagar park, livelihood impacts are assessed on 07 vendors, selling milk, juice, fast-food, ice cream. Out of the 7 vendors,1 vendor (4 family members) is selling milk and tea (having an authorized milk parlor) and operates out of a semi-permanent shop / structure. The

rest 06 vendors (33 family members) are in possession of pushcarts, who are selling items like juice, fast-food, ice cream during after-noon/ evening time, will face temporary livelihood impacts (they will be allowed back to their pre-project location). All are operating their business in the pathway that is proposed for development.

- The project scope includes the construction of the cafeteria within the Nawal Sagar Park. The vendor selling milk is operating from a movable pre-fabricated structure. The structure was provided to the vendor by Rajasthan Cooperative Dairy Federation (SARAS) and the vendor will be able to return the structure upon being provided with the shop at the cafeteria. Hence, the impacts are limited to livelihood loss and no loss of structure is envisaged. The vendor will not incur any permanent livelihood loss or impact. The location of the new shop will be in the same locality / vicinity enabling access to the same clientele and business opportunities as preproject stage. Additionally, the vendor will have a better shop with recognizable rights to the new shop. The milk parlor (1 vendor) will be (i) allowed alternate space to operate during the period of construction and (ii) accommodated / provided a shop within the proposed cafeteria with secure tenure with lease renewal options. This arrangement will enable the milk parlor to have some legal arrangement (recognizable rights to the property i.e. the shop at the cafeteria) with the Bundi Municipality (Nagar Parishad) with secure tenure elevating his status from non-titled vendor to a vendor with recognizable rights to the property. These provisions are adequate to mitigate his loss and provide for continued business opportunity at the same location (the cafeteria is proposed at the Nawal Sager Park space). The cost for construction of shop (in cafeteria) is already mentioned in the bill of quantity (BoQ) and project will facilitate only for shifting of the vendors in new cafeteria. A memorandum of understanding (MOU) between the vendor and the Bundi Nagar Parishad will be drawn prior to shifting of the milk parlor (MOU template attached as Appendix 21).
- 20. All the 7 vendors (including the milk parlor) will be temporarily shifted to an alternate space which is 350 meters from current location (refer figure 18). As alternate location is very near to the existing location where they are presently running their shops (350 meters from current location), hence no loss of clientele or livelihood impacts are envisaged. The shifting is for an interim period/construction period around Nawal Sagar Park and post construction the 6 vendors on pushcarts will be allowed back to their original/pre-project position to continue with their business and the 1 vendor (milk parlor) will be accommodated within the proposed cafeteria within the same vicinity. The alternate location has been selected in discussion with the municipality and the design team. Shifting assistance will be provided to all the 07 vendors.⁴ Assistance for shifting of the shops during non-operative hours will be provided by the project, if required. All the 7 vendors were consulted and they provided their consent to be relocated to the new place for continued business activity (**Appendix 22**).

⁴ Shifting assistance (two times – i. for moving to the alternate location and ii. for moving into the proposed cafeteria - as the person will be required to shift materials and wares twice, once to the temporary relocation site and another time, to the shop proposed to be constructed by the project) will be provided to the 1 vendor (milk parlor).

- 21. During the restoration and replacement of damaged parts of city gates (Chogan Gate, Lanka Gate, and Meera Gate), temporary livelihood impacts are envisaged on 20 shopkeepers (comprising 133 family members). Out of 20 shops, 13 are permanent (authorized shops registered in Nagar Parishad, Bundi), 5 are small cabins, one is a pushcart, and another uses the road ROW for operating business. All the shops, including cabins and vendors, are adjacent to the gates proposed for repair and façade improvement.
- 22. As per discussion with the design team, it was confirmed that scaffolds (BoQ items) will be used during the restoration of gates to avoid/minimize the impacts of commercial activities during the construction period. However, to mitigate any potential impacts (temporary loss of income) on shops during subproject implementation, adequate budget is proposed. In discussion with the technical team, 30 days' are expected to be required to complete the work and accordingly the compensation for temporary livelihood losses has been budgeted. The photographs of the shops are provided in Figure 19, and the category of shops, along with their location, is presented in Table 4

B. Indigenous People

23. Based on the preliminary design, field visits, surveys, and consultations conducted, it is confirmed that there is no impact on the dignity, human rights, livelihood systems, culture, communal assets, and territorial, natural, and cultural resources of indigenous peoples.

III. SOCIO-ECONOMIC INFORMATION AND PROFILE

- 24. The following sections present the socio-economic profile of the households likely to be affected by the proposed works. Based on the inventory of loss survey, 27 (all males), consisting of 170 family members, will potentially be affected under the subproject. The survey provides information on the socio-economic conditions of affected households. A wide range of data has been collected, including social category, type of losses, type of occupation, sources of income, choice of resettlement, etc. The average dependency ratio of affected person households is six, and the average daily income of affected households is ₹1541/day. Of the 27 affected shopkeepers, only one (3.70 %) of affected persons belong to the vulnerable category (scheduled caste).8 The socio-economic profile of affected households is attached in **Appendix 23.**
- 25. **Occupation Profile**: As per the socio-economic survey, 11% of affected persons have a general store, 30 % are selling fancy items, and cloth, 06 affected persons around 22 % are engaged in selling fast food and snack, while 10 APs around 37 % are engaged in other business such as Cobbler, Barbour, Milk parlor etc. Most of them carry their business on movable structures, while few others sit on roads for selling their goods. All the potential affected persons are from male category.





Figure 21: Type of Occupation

26. Income Profile: About 13 (48%-all males) of the households likely to be affected have income ranging between ₹400-1000 per day. Income of 11 (41%-all males) of the households likely to be affected varies from ₹1001-2000 per day, while 3 (11%-all males) households are having an income of ₹4001-5000 per day. Total income of 27 affected persons is ₹ 41,600 and average income is ₹1,541 per day.



27. Caste Profile: Households likely to be affected as per social category have been presented in Appendix 21. Affected persons belonging to General Castes comprise of 07 (26%), Other Backward Class (OBC) comprise 19 (70%), and Scheduled Caste comprise 01 (4%). It can be noted that OBC constitutes the majority in the overall social profile followed by Generals.




Figure 23: Caste Profile

IV. CONSULTATION PARTICIPATION AND DISCLOSURE

A. Public Consultation

28. This draft resettlement plan was prepared in consultation with stakeholders. The key stakeholders consulted during resettlement plan preparation include (i) affected persons. including vulnerable households; (ii) project beneficiaries; (iii) elected representatives, community leaders, and (iv) local government and relevant government agency representatives; and (v) project staff, PMU, PIU, and consultants. Meetings and individual interviews were held with stakeholders, including temporarily affected persons; transect walks, surveys, and interviews were conducted to determine the potential impacts of the subproject. During the meeting, the stakeholders were briefed about the project's technical details and implementation cycle, project benefits and adverse impacts envisaged during construction, environmental and social safeguards, gender inclusion, community participation aspects built into the project, etc. The issues like the extent of the project and development components, benefits of the project, traffic disruptions, and impacts on livelihood were discussed in detail with the stakeholders. The potentially affected persons were informed that compensation would be provided per the losses and appropriate measures would be taken to minimize the impacts. It was also informed that if, despite mitigation measures, there were any impacts on structures and livelihood, those would be compensated in accordance with the agreed entitlement matrix. 117 persons (100 males, 17 females) were consulted. Additional consultations will be conducted during further project preparation and will be continued throughout the subproject implementation. This will include focus group discussions (FGDs) as well. Town-level stakeholder consultation meetings were also held, and subproject scope, its advantage, and the relevance of safeguard issues in subproject implementation were discussed. Details of stakeholder and public consultation, including minutes of city-level committee meetings and stakeholder consultation, are attached in Appendix 25.

B. Information Disclosure

- 29. During the inventory of loss survey, a leaflet in the local language (Hindi) containing details about the proposed works, its impacts, and mitigation measures, including the grievance redress mechanism, was distributed to potentially affected persons. The leaflets and photographs are attached in **Appendix 28**. This resettlement plan will be duly uploaded to ADB and local government's websites. During subproject implementation, construction schedules will be informed to all residents (including affected persons) through signboards before the commencement of works. The signboards will be in the local language will be installed and will include, at a minimum, (i) the section to be affected, (ii) start and end dates, (iii) information on traffic diversion, if any, and (iv) contact information for sharing opinions/questions/grievances.
- 30. During resettlement plan updating, PMU/PIU and CMSC will ensure to issue public notices regarding the cut-off date. For all impacts, the start date of census and socio-economic surveys based on final design and DMS will be considered as cut-off date. Cut-off-date for permanent and temporary impacts will be communicated by CMSC (field support staff) under the supervision of PIU to affected persons. Resettlement plan/ information, education and communication (IEC) materials will be translated in Hindi and will be disclosed/discussed with affected persons (APs) and beneficiaries, including those who are unable to read, in Hindi and/or their local dialect. Consultation and disclosure of entitlements and compensation to affected persons will be further reiterated during DMS and survey at final design stage.

C. Continued Consultation and Participation

31. Consultation and disclosure is a continuous process since from the beginning of the project. Information dissemination will be carried out throughout project circle for the affected

persons including the vulnerable affected persons and other residents. The PMU will extend and expand the consultation and disclosure process during the construction period. The project management consultants will conduct training of contractors (engineers as well as safeguards personnel). The PMU, with the support of CAPPC, will design and conduct a public awareness campaign which shall target all citizens during project implementation. A consultation and participation consultant will be mobilized for preparation and implementation of community awareness activities. Community groups will be consulted and made aware of the civil works and project activities, anticipated impacts and mitigation measures, grievance redress process and contact details of PIU/ PMU personnel prior to execution of work/construction.

V. GRIEVANCE REDRESS MECHANISM

- 32. A project-specific, three-tier grievance redress mechanism (GRM) covers both environment and social issues. The GRM will be established to receive, evaluate, and facilitate the resolution of affected persons' concerns, complaints, and grievances about the social and environmental performance at project level. The GRM will aim to provide a time-bound and transparent mechanism to voice and resolve social and environmental concerns related to the project. Assessment of the GRM designed and implemented for Rajasthan Urban Sector Development Program (RUSDP) shows that the system was effective in timely resolution of grievances in a transparent manner.⁹ The multichannel, project-specific, three-tier GRM is functional at RUSDP, hence the design of GRM for RSTDSP takes into account the proposed institutional structure for RSTDSP and the positive features and learnings from the previous GRM.¹⁰
- 33. **Common GRM**. A common GRM will be in place for social, environmental, or any other grievances related to the project. The implementation of the resettlement plan will follow the GRM described below. The GRM will provide an accessible and trusted platform for receiving and facilitating resolution of affected persons' grievances related to the project.
- 34. Public awareness campaigns within the entire municipal area will ensure that awareness on grievance redress procedures is generated. The nodal officer- safeguards and gender supported by ASO at zonal level, will oversee the conduct of subproject coverage area-based awareness campaigns by the town-level safeguards and safety officers, through the CAPPC. The awareness campaigns will ensure that poor and vulnerable households are made aware of grievance redress procedures and entitlements. Contractors will provide pamphlets to communities prior to start of works and billboards during construction. The pamphlets and billboards will include relevant environmental and social safeguards, GRM information, and contact details of key personnel from PIU and contractors.
- 35. Affected persons will have the flexibility of conveying grievances/suggestions by dropping grievance redress/suggestion forms (See **Appendix 27** for template of grievance registration form. Form will be made available in local dialect) in complaint/suggestion boxes that will be

installed by project PIUs or by e-mail, by post, or by writing in a complaints register in ULB offices/complaints register at contractor's work site or by sending a WhatsApp message to the PIU¹¹ or by dialing the phone number of town level PIU/CAPPC or by dialing a toll-free number.¹² Any aggrieved person can also avail the facilities of online grievance monitoring system 'Rajasthan Sampark' portal to register their grievances which is a parallel mechanism of grievance registration, in addition to the project GRM. 13 Careful documentation of the name of the complainant, date of receipt of the complaint, address/contact details of the person, location of the problem area, and how the problem was resolved will be undertaken and feedback provided to the complainant on action/decision taken. The SSO of town/city level PIU will have the overall responsibility for timely grievance redressal on environmental and social safeguards issues and for registration of grievances, related disclosure, with the assistance of project consultants. In case of grievances that are immediate and urgent in the perception of the complainant, the contractor, and officials of PIU with assistance from CMSC and CAPPC on-site will provide the most easily accessible or first level of contact for quick resolution of grievances. Contact numbers and names of the concerned PIU safeguard and safety officer, contractors, CAPPC and CMSC personal will be posted at all construction sites at visible locations.

- (i) **1st level grievance**. The contractors, PIU executive engineer /assistant engineer designated as SSO (social and environment), CMSC (safeguard staff) and CAPPC can immediately resolve issues on-site, in consultation with each other and will be required to do so within 7 days of receipt of a complaint/grievance. If required, city level monitoring committee (CLMC)¹⁴ will be involved in resolution of grievances at the 1st level;¹⁵
- (ii) 2nd level grievance. All grievances that cannot be redressed within 7 days at field/PIU level will be brought to the notice of Zonal PIU headed by Additional Chief Engineer (ACE). The ACE at zonal PIU will resolve the grievance within 7 days of receipt of compliant/grievance in discussion with the assistant safeguard officer (ASO), field level PIU, CMSC, CAPPC and the contractor;¹⁶
- (iii) **3rd level grievance**. All the grievances that are not addressed by Zonal PIU within 7 days of receipt will be brought to the notice of the PMU. Depending on the nature of grievance, the Project Officer (Social/Environment) at PMU will resolve the grievance within 15 days of receipt of grievance with necessary coordination of Zonal PIU and CMSC and guidance/instruction of additional project director (APD-PMU);
- (iv) Grievances not redressed through this process within/at the project level within stipulated time period will be referred to the CLC/grievance redress committee

(GRC), which has been set up.¹⁷ In its role as a GRC, the CLC will meet whenever there is an urgent, pending grievance. Other grievances can be discussed during its regular meetings. Zonal PIU will inform the CLC regarding any grievances required to be resolved urgently. The GRC will resolve the grievance within 15 days of receiving the complaint. In case of any indigenous peoples impacts in subprojects, the CLC/GRC must have representation of the affected indigenous people community, the chief of the tribe or a member of the tribal council as traditional arbitrator (to ensure that traditional grievance redress systems are integrated) and an NGO working with indigenous people groups.




Figure 24: Grievance Redress Mechanism-RSTDSP

36. The multi-tier GRM for the project is outlined below (Figure 24), each tier having time-bound schedules and with responsible persons identified to address grievances and seek appropriate persons' advice at each stage, as required. The GRC will continue to function throughout the project duration.

17 City Level Committee (CLC)/grievance redress committees (GRCs) has been constituted for each town/city under the Chairmanship of District Collector to provide overall subproject guidance and "to sort out issues and remove hindrances, if any". CLC formed at city-level/district level with members composed of: District Collector as Chairperson and following as members: ULB Commissioner/Mayor/Chairman; Deputy Mayor/Vice Chairman ULB; Chairman / Secretary Urban Improvement Trust (UIT); Head of Zonal/field level PIU as Member Secretary; one representative each from relevant government departments as appropriate (PWD/PHED/Town Planning Department etc.). All CLCs in their role as GRCs will have at least one-woman member/chairperson. In addition, for project-related grievances, representatives of affected persons, community-based organizations (CBOs), and eminent citizens will be invited as observers in GRC meetings. The concerned Member of Parliament (MP) and Member of Legislative Assembly are also part of the CLC.

- 37. The project GRM, notwithstanding, an aggrieved person shall have access to the country's legal system at any stage and accessing the country's legal system can run parallel to accessing the GRM and is not dependent on the negative outcome of the GRM. In case of grievance related to land acquisition, resettlement and rehabilitation, the affected persons will have to approach a legal body/court specially proposed under the RFCTLARRA, 2013.¹⁸
- 38. People who are, or may in the future be, adversely affected by the project may submit complaints to ADB's Accountability Mechanism. The Accountability Mechanism provides an independent forum and process whereby people adversely affected by ADB-assisted projects can voice, and seek a resolution of their problems, as well as report alleged violations of ADB's operational policies and procedures. Before submitting a complaint to the Accountability Mechanism, affected people should make an effort in good faith to solve their problems by working with the concerned ADB operations department. Only after doing that, and if they are still dissatisfied, should they approach the Accountability Mechanism. 19

- 39. **Record-keeping**. The PIU, Bundi town will keep records of grievances received, including contact details of complainant, date the complaint was received, nature of grievance, agreed corrective actions and the date these were affected and final outcome. The number of grievances recorded and resolved, and the outcomes will be displayed/disclosed in the PMU office, PIU offices, and on the web, as well as reported in monitoring reports submitted to ADB on a semi-annual basis.
- 40. **Periodic review and documentation of lessons learned**. The PMU project officers (Social and Environment) will periodically review the functioning of the GRM in each town and record information on the effectiveness of the mechanism, especially on the project's ability to prevent and address grievances.
- 41. **Costs**. All costs involved in resolving the complaints (meetings, consultations, communication and reporting/information dissemination) will be borne by the concerned PIU at town level while costs related to escalated grievances will be met by the PMU. Cost estimates for grievance redress are included in resettlement cost estimates.

VI. POLICY AND LEGAL FRAMEWORK

- 42. The policy framework and entitlements for the RSTDSP are based on:
 - (i) The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act (RFCTLARRA), 2013;²⁰
 - (ii) ADB's Safeguard Policy Statement (SPS), 2009. The salient features of Government and ADB polices are summarized below. The involuntary resettlement principles and procedures to be followed for social safeguards under RSTDSP are detailed out in the resettlement framework document and project implementation shall be carried out in its full compliance; and
 - (iii) The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 and the Rajasthan Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2016.
- 43. The key involuntary resettlement principles of the ADB Safeguards Policy Statement (2009) are:
 - (i) Screen the project early on to identify past, present, and future involuntary resettlement impacts and risks. Determine the scope of resettlement planning through a survey and/or census of displaced persons, including a gender analysis, specifically related to resettlement impacts and risks;
 - (ii) Carry out meaningful consultations with affected persons, host communities, and concerned nongovernment organizations. Inform all displaced persons of their entitlements and resettlement options. Ensure their participation in planning, implementation, and monitoring and evaluation of resettlement programs. Pay particular attention to the needs of vulnerable groups, especially those below the poverty line, the landless, the elderly, women and children, and Indigenous Peoples, and those without legal title to land, and ensure their participation in consultations. Establish a grievance redress mechanism to receive and facilitate

- resolution of the affected persons' concerns. Support the social and cultural institutions of displaced persons and their host population. Where involuntary resettlement impacts and risks are highly complex and sensitive, compensation and resettlement decisions should be preceded by a social preparation phase;
- (iii) Improve, or at least restore, the livelihoods of all displaced persons through (i) land-based resettlement strategies when affected livelihoods are land based where possible or cash compensation at replacement value for land when the loss of land does not undermine livelihoods, (ii) prompt replacement of assets with access to assets of equal or higher value, (iii) prompt compensation at full replacement cost for assets that cannot be restored, and (iv) additional revenues and services through benefit sharing schemes where possible;
- (iv) Provide physically and economically displaced persons with needed assistance, including the following: (i) if there is relocation, secured tenure to relocation land, better housing at resettlement sites with comparable access to employment and production opportunities, integration of resettled persons economically and socially into their host communities, and extension of project benefits to host communities; (ii) transitional support and development assistance, such as land development, credit facilities, training, or employment opportunities; and (iii) civic infrastructure and community services, as required;
- (v) Improve the standards of living of the displaced poor and other vulnerable groups, including women, to at least national minimum standards. In rural areas provide them with legal and affordable access to land and resources, and in urban areas provide them with appropriate income sources and legal and affordable access to adequate housing;
- (vi) Develop procedures in a transparent, consistent, and equitable manner if land acquisition is through negotiated settlement to ensure that those people who enter into negotiated settlements will maintain the same or better income and livelihood status;
- (vii) Ensure that displaced persons without titles to land or any recognizable legal rights to land are eligible for resettlement assistance and compensation for loss of nonland assets;
- (viii) Prepare a resettlement plan elaborating on displaced persons' entitlements, the income and livelihood restoration strategy, institutional arrangements, monitoring and reporting framework, budget, and time-bound implementation schedule;
- (ix) Disclose a draft resettlement plan, including documentation of the consultation process in a timely manner, before project appraisal, in an accessible place and a form and language(s) understandable to affected persons and other stakeholders. Disclose the final resettlement plan and its updates to affected persons and other stakeholders;
- (x) Conceive and execute involuntary resettlement as part of a development project or program. Include the full costs of resettlement in the presentation of project's costs and benefits. For a project with significant involuntary resettlement impacts, consider implementing the involuntary resettlement component of the project as a stand-alone operation;
- (xi) Pay compensation and provide other resettlement entitlements before physical or economic displacement. Implement the resettlement plan under close supervision throughout project implementation;
- (xii) Monitor and assess resettlement outcomes, their impacts on the standards of living of displaced persons, and whether the objectives of the resettlement plan have been achieved by taking into account the baseline conditions and the results of resettlement monitoring. Disclose monitoring reports.

- 44. The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014. The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 came into force on 5 March 2014 and seeks to protect the livelihoods of street vendors while regulating street vending. The Act recognizes street vendors of different types including mobile (moving) vendors, stationary (vending from a particular place), natural markets (spaces where buyers and sellers traditionally congregate), vendors with temporary built-up structures, hawkers, peddlers and squatters. It provides for regulation of street vendors, defines the rights and duties of street vendors and requires definition of designated vending zones, issue of certificates of vending and identity cards to street vendors, and proposes vending fees and maintenance charges. Under the Act, each state government is required to define the public purpose for which a street vendor may be evicted and the manner of relocation, manner of giving notice, and provides for a dispute resolution mechanism. As per the Act, planning and regulation of street vending is to be undertaken at town level by the Town Vending Committee. The Act also provides for social audit of the activities of the Town Vending Committee.
- 45. The Rajasthan Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2016. In exercise of power conferred to state under Section 36 of the central act, the state government has framed rules for implementation of the Act in the state. The State rules outlines the following:
 - (i) The State Government shall constitute a Town Vending Committee (TVC) for every local authority [Section 3 (1)]. In the election for representative of street vendors if due representation of the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, minorities and persons with disabilities is not found, the State Government shall nominate one additional member from amongst such categories in the Town Vending Committee [Section 3 (6)].
 - (ii) Every street vendor, identified under the survey carried out under sub-section (1) of Section 3 of the Act. who has completed the age of eighteen years may be issued a certificate of vending by the Town Vending Committee. [Section 8 (1)]
 - (iii) The Town Vending Committee at its office shall maintain all necessary records as are required to be maintained by it under the Act and these rules and also a soft copy duly updated into its computer system. All records relating to allotment of space to street vendors shall be preserved at least for five years and beyond that till the period of currency of their licenses and for such further period in cases where any litigation with regard to any place is pending. All records including maps, road plans showing existing site of street vending shall be a permanent record of Town Vending Committee. (Section 7)
 - (iv) The Town Vending Committee shall take final decision about vending zones along with their holding capacity as worked out by the local authority. TVC shall be responsible for issuing, withholding, suspending and cancelling of the vending certificate. [Section 14 (1)]
 - (v) The State Government shall constitute a Grievance Redressal and Dispute Resolution Committee at each divisional headquarters. (Section 15)
 - (vi) Any street vendor having grievance for any matter under the Act, except those matters as are specified in Section 11 of the Act, may file an application in writing. (Section 16).
- 46. Core involuntary resettlement principles for the RSTDSP to be followed for each subproject, including sample subprojects are:

- (i) land acquisition, and other involuntary resettlement impacts will be avoided or minimized exploring all viable alternative subproject designs;
- (ii) adverse impacts to indigenous peoples' dignity, human rights, livelihood systems and culture as well as to the natural and cultural resources of indigenous peoples will be avoided:
- (iii) where unavoidable, time-bound resettlement plans (RPs)/ resettlement and indigenous people plan (RIPPs)/Indigenous Peoples Plan (IPPs) will be prepared and affected persons will be assisted in improving or at least regaining their preprogram standard of living;
- (iv) full information and close consultations with affected persons including consultation with affected persons on compensation, disclosure of resettlement information to affected persons, and participation of affected persons in planning and implementing subprojects will be ensured;
- (v) vulnerable groups will be provided special assistance; beneficial impacts to indigenous peoples will be ensured through special measures identified in the resettlement plans/IPP/RIPP, if any.
- (vi) payment of compensation to affected persons including non-titleholders (e.g., informal dwellers/squatters, and encroachers) for acquired assets at replacement rates;
- (vii) payment of compensation and resettlement assistance prior to the contractor taking physical acquisition of the land and prior to the commencement of any construction activities;
- (viii) provision of income restoration and rehabilitation; and
- (ix) establishment of appropriate grievance redress mechanisms.
- 47. **Comparison of Government and ADB Policy.** The RFCTLARR Act, 2013 represents a significant milestone in the development of a systematic approach to address land acquisition, rehabilitation and resettlement collectively in India. RFCTLARRA, 2013 has also laid down similar principles like ADB's SPS, 2009 and focus on avoiding or minimizing involuntary impacts, if not restoring and enhancing the quality of life of affected families irrespective of title to the land. Table 8 presents a comparison of the Government of India policies (RFCTLARRA, 2013, the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 and the Rajasthan Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2016), the state policies vis-à-vis ADB's SPS, 2009, and identifies gaps and gap filling measures.

VII. ENTITLEMENTS, ASSISTANCE AND BENEFITS

A. Types of Losses and Affected Person Category

- 48. The anticipated types of losses due to the proposed subproject components under RSTDSP comprise (i) temporary loss of livelihood; (ii) impacts to vulnerable persons (amongst the affected persons).
- 49. According to ADB SPS, 2009 in the context of involuntary resettlement vis-à-vis economic impacts, the affected persons (APs) are those who are physically and economically displaced (loss of productive land, structures, assets, access to assets, income sources, or means of livelihood). The absence of formal and legal title to the land does not bar the affected person from receipt of compensation and resettlement assistance from the project. Vulnerable affected persons are eligible for additional compensation and assistance and are to be accorded priority in employment in project related construction activities.

B. Entitlements

- 50. As per agreed resettlement framework for the project,²¹ all the affected persons will be eligible for compensation for temporary loss of livelihood/income. Unavoidable livelihood disruption due to construction activities will be compensated.²² For this subproject, the maximum estimated period of disruption during execution of work is 30 days. All affected persons will also be compensated for the time lags (7% annual inflation in survey income is provisioned) between payment of compensation and the time of survey. 'Shifting assistance' (lump sum ₹1500) will be paid to all affected persons irrespective of their business type. All affected persons who are identified as vulnerable will be eligible for special assistance amounting to ₹9,000 as onetime assistance under temporary impacts for livelihood restoration.
- 51. The titleholders are handled through RFCTLARRA, 2013 and the preliminary notification by the competent authority would be the cut-off date as per the law. The start date of the census and socio-economic surveys based on final design and DMS is the cut-off date for all non-titleholder affected persons. All affected persons who are identified in the subproject areas on the cut-off date²³ will be entitled to compensation for their loss, and rehabilitation measures (as outlined in the entitlement matrix below) sufficient to assist them to improve or at least maintain their pre-project living standards, income-earning capacity and production levels. Affected persons who settle in the affected areas after the cut-off date will not be eligible for compensation and assistance. Affected persons will be provided 30 days' advance notice to ensure no or minimal disruption in livelihood. If required, they will also be assisted to shift to alternate locations. For example, they will be assisted to shift to the other side of the road or to a nearby location within the immediate vicinity, where there is no construction. Ensuring there is no income or access loss during subproject construction is the responsibility of PIU, Nagar Parishad, Bundi and project contractor.

- 52. If construction activities result into unavoidable temporary livelihood disruption, compensation for loss of income or a transitional allowance for the period of disruption, whichever is greater, will be provided. Vulnerable affected persons will be given priority in project construction employment and will be provided with additional special assistance for income restoration support. Compensation and assistance to affected persons must be made prior to possession of land/assets and prior to the award of civil works contracts. Since most affected households have moveable stalls, ID cards should be distributed 30 days before compensation. In summary, temporarily affected persons will be provided with:²⁷
 - 30 days' advance notice regarding construction activities, including duration and type of disruption.
 - Contractor's actions to ensure there is no income/access loss consistent with the initial environmental examination. This includes, increased workforces to finish work in areas with impacts on access, timing of works to reduce disruption during business hours, phased construction schedule. and working one segment at a time and one side of the road at a time
 - Assistance to mobile vendors/hawkers to temporarily shift for continued economic activity. For example, assistance to shift to the other side of the road or within immediate vicinity where there is no construction.
 - For construction activities involving unavoidable livelihood disruption, compensation for lost income or a transitional allowance for the period of disruption whichever is greater.

VIII. RESETTLEMENT BUDGET AND FINANCING PLAN

- 53. The resettlement budget for conservation and development of heritage sites of Bundi town subproject components includes resettlement assistance, as outlined in the entitlement matrix and contingency provision amounting to 20% of the total cost and is presented in Table 10. Community awareness and public participation consultants (CAPPC) will be involved in facilitating the disbursement process and will facilitate opening bank of accounts for the affected persons who do not have bank accounts. The total resettlement cost for the subproject is ₹1,835,652 (Rupees 1.83 million). The Superintending Engineer / Executive Engineer of PIU will be issuing sanction order for compensation payment to affected persons which shall be released through electronic clearance service/National Electronic Fund Transfer (ECS/NEFT) transaction from bank, through concerned Treasury of the state administration.
- 54. The details of resettlement plan budget estimate are the following:
 - A. Total number of affected persons A total of 27 persons have been identified as project affected persons during income loss survey. Out of the 27 persons, one vendor having milk parlor will not be allowed back in the road ROW and instead will be provided with a shop in the cafeteria to be constructed by the project at the same location). The milk parlor (1 vendor) currently operating on the roadside from a movable pre-fabricated structure, will be (i) allowed alternate space to operate during the period of construction and (ii) accommodated / provided a shop within the proposed cafeteria with secure tenure. These provisions are adequate to mitigate and restore his loss and provide for continued business opportunity at the

The structure was provided to the vendor by Rajasthan Cooperative Dairy Federation (SARAS) and the vendor will be able to return the structure upon provided with the shop at the cafeteria.

same location (the cafeteria is proposed at the Nawal Sager Park space). The vendor will not incur permanent livelihood loss or impact. The location of the new shop will be in the same vicinity enabling access to the same clientele and business opportunities as pre project stage. Additionally, the vendor will have a better shop with recognizable rights to the new shop. The budget provisions for 1 vendor include (i) loss of livelihood for temporary period and (ii) Shifting assistance (two times – i. for moving to the alternate location and ii. for moving into the proposed cafeteria - as the person will be required to shift materials and wares twice, once to the temporary relocation site and another time, to the shop proposed to be constructed by the project). Civil works at this particular section (near Nawal Sagar Park) will commence only after payment of compensation and relocation of vendors to the alternate location site (7 shops situated near Nawal Sagar Park having movable structures).

- 55. The 27 persons have been identified as project affected persons during income loss survey. Temporary livelihood losses are estimated for 30 days for each of the 27 affected person under this subproject.
 - **B.** Total number of vulnerable affected persons As per socio-economic survey, 01 affected person is from vulnerable category. Vulnerability assistance for RSTDSP-additional financing has been budgeted amounting to ₹ 9,000 per household, in accordance with the entitlement matrix (temporary loss of livelihood).
 - Compensation against daily income loss as per income loss survey, the total daily income for all surveyed affected persons is ₹ 41,600 and accordingly, the average of this total figure i.e., ₹ 1541 has been considered as average daily income of affected persons (it is higher that the daily minimum wage rate of Rajasthan, which is ₹ 252). This average has been applied for all 20 affected persons in budget estimate. During subproject implementation, payment will be disbursed to permanent shop owners as per their disclosed taxable income as submitted with Income Tax Department/s.
 - D. Shifting assistance Shifting assistance shall be provided to movable structures. Out of 27 potentially affected persons, 14 is having movable structure while 13 possess permanent shops, facing temporary access disruption. Out of the 14 movable vendors, for the 13 vendors a uniform amount of ₹ 1500 is proposed as shifting assistance. For the 1 movable vendor (milk parlor) additional shifting assistance is considered to move to the cafeteria.
 - **E. Contingency amount** Contingency amount of 20% is also included in budget provisions as cushion for any unforeseen impacts during execution of civil work.

56. The PIU (with CMSC support staff at PIU level) and CAPPC will be involved in facilitating the disbursement process and will facilitate opening bank accounts for the affected persons who do not have bank accounts. PIU will prepare compensation details including names of affected persons, bank account details, compensation amount, and submit to the district treasury to enable timely compensation payments prior to start of civil works. PIU with support from CMSC field staff and CAPPC will monitor compensation payment to affected persons. CMSC will support the PIU to monitor, document and maintain evidence of payments in PIU's records. Zonal PIU will monitor all town level PIUs for compliances in this respect.

IX. INSTITUTIONAL ARRANGEMENTS AND IMPLEMENTATION SCHEDULE

A. Institutional Arrangements

- 57. The implementation arrangements include Local Self Government Department (LSGD), Government of Rajasthan will be the executing agency of the project. The department will be responsible for overall strategic guidance and for ensuring compliance with ADB's Ioan covenants. RUDSICO is the implementing agency for the RSTDSP, responsible for technical supervision and project implementation. The RUDSICO Board under the Chairmanship of the Minister for Urban Development, and members comprising of the Chief Secretary, Secretaries of LSGD, Finance, Planning, PWD, PHED and the project director, RUIDP as member secretary. It shall have full powers to decide on matters related to RSTDSP. The Board will take needful policy decisions, provide administrative and financial approvals, expedite clearances of project matters, ensure inter-departmental coordination and provide guidance to the PMU. As per GO dated 21 Feb 2018, all powers and responsibilities of earlier state level empowered committee (SLEC, under RUIDP Phase III) have now been transferred to RUDSICO Board.
- 58. RUDSICO already established a state-level PMU, headed by dedicated project director, and housed in EAP division of RUDSICO. For the purpose of project implementation, two zonal PIUs, at Jaipur and Jodhpur, headed by ACE has been established. At field level, town-level PIUs will be established for project implementation on ground.

B. Safeguard Implementation Arrangement

59. **Project Management Unit**. RUDSICO already establish a state-level PMU, headed by dedicated project director, and housed in EAP division of RUDSICO. For the purpose of project implementation, 2 zonal PIUs, at Jaipur and Jodhpur, headed by ACE has been established. At PMU, there are 2 dedicated project officers: (i) project officer (Environment); and (ii) project officer (Social and Gender), who is responsible for compliance with the environmental, social safeguards and gender in project implementation. Project officer (social and gender) have an overall responsibility in implementation of the RSTDSP as per the social safeguards frameworks (resettlement framework and indigenous people planning framework [IPPF]) and gender equality and social inclusion (GESI) Action Plan agreed between ADB and the government, including appropriate monitoring and reporting responsibilities. Project Officer (Social and Gender) at the PMU is supported by the social safeguards specialist (SSS) and the gender specialist of PMCBC. Key safeguard and gender mainstreaming related tasks and responsibilities at the PMU level are as follows:

60. Social Safeguards and Gender

- (i) Ensure subprojects conform to the agreed subproject selection criteria for the project;
- (ii) Review and finalize subproject involuntary resettlement and indigenous people category;
- (iii) Oversee preparation of resettlement plans, RIPPs and DDRs; confirm existing resettlement plans and DDRs are updated based on detailed designs, change in scope of work, and that new subproject resettlement plans, RIPPs and DDRs are prepared in accordance with the resettlement framework and IPPF prepared for the project:
- (iv) Liaise with district administration for land acquisition, transfers; ensuring land availability;

- (v) Ensure that resettlement plans, RIPPs and DDRs are included in the bidding documents and civil works contracts;
- (vi) Provide oversight on social safeguard management aspects of subprojects and facilitate and follow-up to ensure that any delays in land procurement are addressed;
- (vii) Ensure and monitor the provision in the contract to include the indigenous people to benefit from the facilities constructed under the project;
- (viii) Facilitate and ensure compliance with all government rules and regulations regarding no objection certificates, third party certificates for negotiated settlement or donation, land ownership, and transfer details for each site, as relevant;
- (ix) Supervise and guide the zonal PIUs and city level PIUs to properly carry out the social safeguard monitoring;
- (x) Review, monitor, and evaluate the effectiveness with which the resettlement plans, RIPPs and provisions of DDRs are implemented, and recommend corrective actions to be taken as necessary;
- (xi) Consolidate monthly social safeguard and gender monitoring reports from PIUs and the CMSCs and submit semi-annual social safeguard monitoring reports to ADB;
- (xii) Ensure timely disclosure of final resettlement plans, RIPPs and DDRs in locations and form accessible to the public and affected persons;
- (xiii) Address any grievances brought about through the grievance redress mechanism promptly;
- (xiv) Oversee the assessment of training needs of affected persons and vulnerable persons by PIUs and/or PMCBC, coordinate training activities and convergence with the livelihood programs of the government;
- (xv) Ensure effective implementation of GRM at all levels;
- (xvi) Coordinate database management for social safeguards implementation and monitoring;
- (xvii) Coordinate public awareness campaigns by the PIUs including resettlement provisions with the help of print and electronic media; and
- (xviii) Serve as Gender Focal Point at PMU, which would involve overseeing with the support of PMCBC, the implementation, monitoring and reporting on the GESI action plan.
- 61. The PMU is being supported by three institutional consultants under the supervision and control of project director, PMU: (i) the PMCBC is supporting the PMU; (ii) 2 CMSC are supporting the two zonal PIUs and town-level PIUs; and (iii) community awareness and public participation (CAPP) Consultants, will support the zonal PIUs and town-level PIUs.
- 62. **Zonal Project implementation units.** There are 2 zonal level PIUs at Jaipur and Jodhpur. Under each zonal PIU, there are city/town level PIUs, for ease of day-to-day monitoring and management at local level. The Additional Chief Engineer at each Zonal PIU is serving as the Nodal Officer, Safeguards and Gender. Each Zonal PIU is staffed with an assistant safeguards officer (ASO Environmental and Social Safeguards) who are assisting PMU project officer (environment/social) in implementation of the environmental/social safeguards and GESI Action Plan in PIUs under its jurisdiction. Zonal PIUs undertaking internal monitoring and supervision and record observations throughout the project period to ensure that the safeguards and mitigation measures are provided as intended.

- 63. The zonal level ASO is overseeing safeguards implementation by the city/town level PIUs, coordinates public consultations, information disclosure, regulatory clearances and approvals, implementation of resettlement plans, RIPPs, EMP implementation, and grievance redressal.
- 64. The Zonal PIUs will oversee and support social safeguards and gender equality and social inclusion action plan implementation by the PIUs at town/city level, through the following key tasks:
 - (i) fill up involuntary resettlement and indigenous people impact checklist and classify the project;
 - (ii) supervise CMSC to coordinate with PIUs and safeguards field staff for conduct census and socio-economic surveys, detailed measurement surveys, and verification surveys of affected persons, conduct consultations with affected persons, finalize the list of affected persons, prepare and/or update the resettlement plan, RIPP and DDR, with the assistance of CMSC and submit to PMU for review and approval and submission to ADB;
 - (iii) supervise PIUs to inform affected persons about (a) the project cut-off date; (b) public notice for the schedule of land acquisition and/or occupation; (c) entitlement matrix; and (d) compensation packages against different categories of loss and a tentative schedule of land clearing and/or acquisition for the start of civil works activities;
 - (iv) coordinate valuation of assets, such as land and trees of various species. Finalize compensation packages based on proper due diligence and assessment;
 - facilitate land acquisition and compensation processes in consultation with the district administration; coordinate, supervise, and monitor the disbursement of compensation;
 - (vi) Support PIUs to obtain no objection certificates, land documents, and third-party certifications as required for the subproject, in coordination with PIUs;
 - (vii) support PMU to include resettlement plans, RIPPs and DDRs in bidding documents and civil works contracts;
 - (viii) guide PIUs to oversee implementation of avoidance and mitigation measures in the resettlement plans, RIPPs and DDRs by contractors, including compliance with all government rules and regulations; take necessary action for obtaining ROW;
 - (ix) guide and monitor PIUs to oversee resettlement plans, RIPPs and DDR, and gender equality and social inclusion action plan implementation and maintenance of data for monitoring by contractors;
 - (x) ensure listing of town wise BPL households;
 - (xi) assist in conducting needs assessment to list skills relevant to the sector;
 - (xii) assist to identify participants for livelihood and skilling training for women and members of other vulnerable groups;
 - (xiii) ensure that the project maintains sex disaggregated data on staff, consultants, construction workforce participation, labor and project related trainings;
 - (xiv) ensure that gender focal points are nominated in town level PIUs;
 - (xv) ensure and monitor the provision in the contract to include the indigenous people to benefit from the facilities constructed under the project:
 - (xvi) to ensure that corrective actions are taken when necessary to ensure compliance with SPS and loan covenants;
 - (xvii) submit monthly social monitoring reports to PIUs and PMU;
 - (xviii) quide PIUs to conduct continuous public consultation and awareness;
 - (xix) address any grievances brought about through the grievance redress mechanism promptly;

- (xx) organize an induction course for the training of contractors, preparing them on resettlement plans, RIPPs, DDR, and GESI action plan implementation, social safeguard, and gender monitoring requirements related to mitigation measures, grievance redress mechanism and on taking immediate action to remedy unexpected adverse impacts or ineffective mitigation measures found during implementation;
- (xxi) liaise with the district administration, and line departments for dovetailing government's schemes for income generation and development programs for affected people, as and when required; and
- (xxii) assist in the implementation, monitoring, and reporting progress of gender equality and social inclusion action plan.
- Town/City Level Project Implementation Unit. The town-level PIUs will be responsible 65. for the quality of works executed under the project and being guided by the zonal PIUs. The city/town PIUs will be responsible for implementation of the IEE/resettlement plan/ RIPP/GESI action plan. The town-level PIUs will be headed by a project manager (executive engineer or assistant engineer) and will be supported by CMSC field staff. Environment specialist of CMSC will be assisting PIU in implementation of environmental safeguard. Social and gender specialist of CMSC will be assisting PIU in implementation of social safeguard and GESI related tasks. At each PIU, the assistant project manager will have an additional responsibilities of safeguard tasks and designated as SSO. The SSO will be assisted by the social and gender specialist and environment Specialist of CMSC in reviewing updated/revised IEEs, conducting surveys for updating of resettlement plan/due diligence report, public consultation and disclosure, assessment of entitlement and computation of compensation other than those covered under the RFCTLARRA, 2013, etc. The SSO, with the support of CMSC Social safeguards and Gender Specialist and CMSC field support staff, assisting Zonal ASO and PMU project officer (social) in implementation of the following key tasks. They are responsible for coordination of field level activities related to safeguards conducted by the DBO contractor and CMSC. Key role and tasks of town/city level PIU will be:
 - (i) Provide field data to fill up IR/IP impact checklist and classify the project;
 - (ii) Conduct census and socio-economic surveys, detailed measurement surveys, and verification surveys of affected persons, conduct consultations with affected persons, prepare list of affected persons, provide all data required to prepare/update resettlement plans/DDRs/RIPPs with the assistance of CMSC field support, and ensure updated information is submitted to zonal PIU for preparation/updating of documents with CMSC and DBO contractor's support;
 - (iii) Inform affected persons about tentative schedule of land acquisition/occupation, entitlement matrix and compensation packages against different categories of loss, and cut-off date;
 - (iv) Coordinate valuation of assets, such as land, trees of various species, etc. Based on proper due diligence and assessment, prepare compensation packages;
 - (v) Coordinate, supervise and monitor disbursement of compensation;
 - (vi) Obtain no objection certificates (NOCs), land documents, third party certifications as required for the subproject;
 - (vii) Support Zonal PIUs to prepare/update resettlement plans/RIPPs /DDRs;
 - (viii) Oversee day-to-day implementation of impact avoidance and mitigation measures in resettlement plans/DDRs/RIPPs and EMP by contractors, including compliance with all government rules and regulations particularly health and safety, take necessary action for obtaining ROW;
 - (ix) Oversee maintenance of data for monitoring, by consultants and contractors;

- (x) Implement corrective actions when necessary to ensure no adverse social impacts;
- (xi) Submit monthly social monitoring reports to zonal PIU;
- (xii) Conduct continuous public consultation and awareness;
- (xiii) Set up GRM at field/site/PIU level and ensure it is fully functional. Address any grievances brought about through the grievance redress mechanism in a timely manner:
- (xiv) Ensure that induction course for the training of contractors is conducted regularly. Prepare contractors (with consultants' support) on resettlement plans/DDR/RIPP/ GESI action plan implementation, social safeguard and gender monitoring requirements related to mitigation measures, health and safety and on taking immediate action to remedy unexpected adverse impacts or ineffective mitigation measures found during the course of implementation;
- (xv) Liaise with the District Administration and line departments for dovetailing Government's schemes for income generation and development programs for affected persons, as and when required;
- (xvi) Supervise the work of all consultants at town level (CMSC, CAPPC).
- (xvii) Undertake day-to-day implementation of final resettlement plans and GESI action plan;
- (xviii) Provide field level information required to prepare periodic safeguard monitoring reports in a format acceptable to ADB and quarterly GESI action plan updates in the format provided in PAM;
- (xix) Ensure relevant data on implementation of GESI action plan is collected and a gender-sensitive communication strategy and information, education and communication (IEC) materials are designed, illustrating key social and behavioural messages related to hygiene, sanitation, and health jointly with the communication specialist and in accordance with the GESI action plan; and
- (xx) Extend support in carrying out awareness campaigns in project towns.
- 66. **Contractor**. The contractor will appoint an environment, health and safety (EHS) engineer who is responsible on a day-to-day basis for (i) ensuring implementation of EMP, (ii) coordinating with the town-level PIUs and environment specialists of project consultant teams; (iii) community liaison,³³ consultations with interested/affected people, (iv) field-level grievance redress; and (iv) reporting.
- 67. After approval of resettlement plan (RP) and IEE, a copy of the EMP or approved SEMP will be kept on-site during the construction period at all times. Non-compliance with, or any deviation from, the conditions set out in the EMP or SEMP constitutes a failure in compliance and will require corrective actions. The EARF and the IEEs specify responsibilities in EMP implementation during design, construction and operation and maintenance (O&M) phases.
- 68. The contractor will have a dedicated social outreach team (SOT) and designated social supervisor, who will be a graduate in social science/sociology and would have at least 5 years of experience in resettlement planning and implementation and engage with the PIU, CAPPC and CMSC on social safeguards, health and safety, and core labor standards. The key role of the Contractor's Social Supervisor related to social safeguards will be to:

- (i) Work in close coordination with the PIU, CMSC and PMCBC engineers and social safeguards personnel to help finalize detailed design keeping the safeguard principles adopted for the project in view;
- (ii) Support project consultants in achieving subproject goals; and undertake consultations with appropriate stakeholders including Nagar Nigam Officials as and when required in presence of PIU/PMU Officials Consultants:
- (iii) Ensure strict adherence to agreed impact avoidance and mitigation measures in the resettlement plan/DDR/RIPP during implementation;
- (iv) Assist with grievance redressal and ensure recording, reporting and follow-up for resolution of all grievances received; and
- (v) Submit monthly progress reports to PIU/PMU on subproject progress.
- 69. **Civil works contracts**: The resettlement plans /RIPPs are to be included in bidding and contract documents and verified by the PIUs and PMU. All contractors will be required to designate an Environment, Health and Safety (EHS) supervisor to ensure implementation of EMP/resettlement plan social safeguard provisions in the agreed resettlement framework for the Project during civil works and O&M, who will also have the responsibility for communication with the public under the guidance of PMU/PIUs and grievance registration. Contractors are to carry out all mitigation and monitoring measures outlined in their contract.
- 70. The PMU and PIUs will ensure that bidding and contract documents include specific provisions requiring contractors to comply with: (i) all applicable labor laws and core labor standards on (a) prohibition of child labor as defined in national legislation for construction and maintenance activities; (b) equal pay for equal work of equal value regardless of gender, ethnicity, or caste; and (c) elimination of forced labor; and with (ii) the requirement to disseminate information on sexually transmitted diseases, including HIV/AIDS, to employees and local communities surrounding the project sites.




Figure 25: Safeguard Organogram - RSTDSP

C. Institutional Capacity and Development

- 72. RUSIDCO-EAP has experienced project staff for social safeguards, with knowledge and experience of ADB social safeguard policies and their implementation. However, retirement of existing staff during project implementation, transfer of candidates or recruitment/designation of new candidates as safeguards officers at zonal or town level will require training of the new staff and officers who will be involved in project preparation and implementation of this project. The PMCBC Social Safeguard Specialist will be responsible for training the PMU's safeguards officers (environmental and social), and PIUs' engineers and social safeguards officers. The resettlement framework includes indicative training modules on safeguards. The PMCBC will coordinate with PMU and PIUs on specific capacity development program.
 - (i) sensitization on ADB's Policies and guidelines on social and indigenous people safeguards (ADB's Safeguard Requirement 2 and 3: Involuntary Resettlement and Indigenous Peoples) including meaningful consultation, GRM and accountability mechanism:
 - introduction to the assessment of involuntary resettlement and indigenous peoples impacts and mitigation measures, including best practices, in the design, construction, operation and maintenance of water supply, sewerage, roads, and drainage subprojects;
 - (iii) preparation and review of resettlement plans/RIPPs/DDRs based on preliminary design, and updating of the documents based on the final design;
 - (iv) improved coordination within nodal departments;
 - (v) disbursement of compensation, consultation; and
 - (vi) monitoring and reporting requirements.
- 73. Table 12 provides the indicative training needs assessment. The cost of trainings will be borne under the Project's capacity building program by PMU. The detailed cost and specific modules will be customized for the available skill set after assessing the capabilities of the target participants and the requirements of the project by the SSS of PMCBC.

D. Implementation Schedule

74. The project will be implemented over a period of 18 months. The resettlement plan implementation schedule will vary from subproject to subproject. In general, the project implementation will consist of the three major phases, namely project preparation, land acquisition (if required), and rehabilitation of affected persons. The implementation of the resettlement plan will include: (i) identification of cut-off date and notification, (ii) verification of losses and extent of impacts, (iii) finalization of entitlements and distribution of identity cards, (iv) consultations with affected persons (APs) on their needs and priorities, and (v) resettlement, provision of compensation and assistance, and restoration for affected persons (APs). The PMU and zonal PIU will ensure that no economic displacement of affected persons will occur until: (i) compensation at full replacement cost has been paid to each displaced person for project components or sections that are ready for construction; (ii) other entitlements listed in the resettlement plan are provided to the affected persons. However, public consultation and monitoring will be continued on an intermittent basis as needed during the entire duration of the project. The implementation schedule for the subproject is given in **Table 13**.

X. MONITORING AND REPORTING

75. Resettlement plan implementation will be closely monitored to provide the PMU with an effective basis for assessing resettlement progress and identifying potential difficulties and problems. Internal monitoring will be undertaken by the PIU (through the SSS) with assistance from the PMU SPO. The socio-economic status of the affected persons will be monitored to ensure that their living standards are restored to pre project level or improved. Monthly progress reports will be prepared by the consultants and contractors and submitted to the PMU. PMU will consolidate the same and will submit semi-annual monitoring reports to the ADB for approval. Monitoring reports will be disclosed on PMU and ADB websites. (refer sample monitoring template in **Appendix 30).**

XI. NEXT STEPS

- 76. Following points/issues were identified that will be updated prior to start of civil works and reported to ADB for approval.
 - (i) Land records of Gates and *Chatri*s will be collected and same will be appended in updated resettlement plan.
 - (ii) Alternate location for the 7 vendors running their business near Nawal Sagar Park is identified for their continued business opportunity during the period of construction. No construction activity will be initiated prior to allotment of alternate space to the 7 vendors operating in front of Nawal Sagar Park. Agreement between 1 vendor (milk parlor) and the Municipality (Nagar Parishad) will be drawn based on mutually agreeable terms and conditions for allotment of shop in the cafeteria with lease/tenure renewable facility.
 - (iii) Upon completion of work near Nawal Sagar Park, all the 6 vendors will be allowed back to their original position for conducting business. Due diligence will be undertaken for the above activities and same will be reported to ADB through semi-annual social monitoring report.
 - (iv) Formal and informal consultations will be carried out, including but not limited to focus group discussions (FGDs), public meetings, community discussions, and indepth and key informant interviews through the implementation of the project and the same will be reported to ADB through the semi-annual social monitoring reports. In case there is a change to project design or additional scope is proposed during implementation, ADB will be promptly informed; social safeguards document will be updated and submitted to ADB for approval.
 - (v) Mitigation measures as proposed in this resettlement plan will be taken by the contractor and robust monitoring plan will put in place by the PIU and PMU to ensure its compliance. All safety measures will be taken during civil work.








Appendix 14: Location map of Sheriyo Ki *Chatri*

The mutually agreed terms and conditions are as follows:

- 1. That the First Party is the landowner of the Nawal Sagar Park bearing Khasra No. XXXX, with transferable right to use the property is going for redevelopment of the Nawal Sagar Park which will include construction of cafeteria.
- 2. The Second Party (authorized milk parlor vendor near Nawal Sagar Park) have no reservation / objection for the said revelopment activities in the Nawal Sagar Park.
- 3. That the Second Party (authorized milk parlor vendor Nawal Sagar Park) will be provided with 1 shop ofdimention in the proposed Cafeteria to be constructed at Nawal Sagar Park with secure tenure.
- 4. The shop will be provided free of cost / with nominal deposit of......to the Second Party and the monthly rent will be as per the existing and prevalent norms under Bundi Nagar Parishad.
- 5. During redevelopment of Nawal Sagar Park, as space is available near the proposed site (at a distance of mere 350 meter); hence the Second Party will relocate in that space temporarily during redevelopment / construction activities and period. Civil works at this particular section will commence only after payment of compensation and relocation of vendors to the alternate location site. The re-development period will depend on the work schedule of the subproject and the Second Party will have no objection to such scheduling of work.

Appendix 22: Confirmation from Vendors regarding Temporary Relocation

Consultation with the vendors operating near Nawal Sagar Park was conducted on 1 August 2023 and proposed works and its impacts was conveyed in details. It was deliberated that all of them will be shifted to other adjacent location at about 350 meters away, prior to execution of works. Since the proposed area is very near to their current location, their livelihood will not be impacted. During the consultation, the vendors expressed the need for timely execution of works to minimize impact of their business.

Objectives of Program:

The primary objective of workshop was to create the awareness, through which the people will be sensitized about the benefits of upcoming project in Bundi town along with potential social and environmental impacts and mitigation measures.

Minutes of the Public Awareness & Consultation

Public Awareness Program & Stakeholder Consultation was held on 24.03.2023 at Meeting Hall, Collectorate office, Bundi. Officials of Nagar Palika (Chairmen, Councillor), Official of PHED and SDM of Bundi town and local public & Public representative were shown their participation.

Mr. Chiranjilal, Gender Expert of CAPPC, RUIDP, welcomed the distinguished guests and participants.

Mr. Manish Arora, SE, PIU, Bundi in his introductory speech, briefed about the Project Development Objectives (PDO). He explained that newly developed area of Bundi is unable to cater the water demand due to growing population therefore under water supply scheme water treatment plant (WTP), CWR, OHSR, pipeline networks, house service connection etc are considered as per the requirements of the town. He also deliberated that the capacity of existing STP is not enough due to increase of sewer connections, hence additional 6.5 MLD capacity STP is proposed under sewer scheme. SE, PIU also apprised that in low lying areas where the sewerage line is not feasible, Feacal Sludge & Septage Management (FSSM) has been proposed. It was also informed that the project is based on Design Built & Operate (DBO) contract, hence contractor bounded to maintain the created project assets for 10 years.

It was also apprised by Mr. Manish Arora, SE, PIU, Bundi that Bundi is an important tourist destination in the state of Rajasthan and there are many tourist sites (Gates, Baoris, Chatirs and Nawal Sagar Kunds).

Therefore, at Nawal Sagar Lake- Cleaning of Nawal Sagar Lake intercepting of drain

into Nawal Sagar, Enhancing the capacity of Nawal Sagar Lake, Beautification of the two sides of Lake Edge and at **Nawal Sagar Park**- Development of the entrance plaza, Development of the interconnection of three different parks into one, Development of alternate route for the public use, Interconnecting the park and Nawal Sagar lake, redesigning of road between the park and lake into the Promenade, Development of food court, public utilities and parking spaces etc.

The basic objective of this subproject is to improve the economic development by providing the infrastructure and service in the city beautification. The improvement of quality of life and thereby effective contribution of beneficiary people in the economic activity is expected.

Smt. Nishta Arya, Architect, PMCBC briefed about the proposed components through power point presentation to the participants.

Mr. Shrikant Jangir, EE, PIU, apprised that water logging is reported in rainy season in low laying areas of the town due to the lack of proper drainage and discharge resulting rain water comes on the roads and create water logging at various places. Hence for proper drainage and safely discharge of stagnated water and reduce incidences of water logging, improvement of 14.21 Km. existing drain improvement works is proposed for Bundi town under RUIDP project. The drain considered for improvement are: lanka gate - Ice factory to UIDSSMT Nallah/drain, From Agarwal Dharamshala to Highway Nallah on Silor Road, From Khoja Gate to Ice Factory, From Gurudwara Devpura to Nanak bridge circle and from Jait Sagar to Devpura.

Mr. Vardan Srivastav, Environmental Specialist, CMSC, briefed them about the project activities and requirement of environmental monitoring periodically. He briefed about environmental laws and statutory clearances required for the project, environmental issues and mitigation measures, role and responsibility contractor to ensure environmental compliances. He emphasized that it is the responsibility of the contractor to ensure that hard barricading (for sewer line) with retro-reflective arrangements for all the open trenches with GI sheets should be provided so that no person or animal can enter/fall in trench. An information board should also be firmly fixed at every such location giving information about the duration of closure of works and contractor contact details for grievances, if any.

Mr. Bhupander Kaushik, Social Safeguard Support, PMCBC- RUIDP briefed them about the main features of ADB safeguard policy. He deliberated that works should be undertaken in such a way that impacts should be minimized. If any impacts will be envisaged, specially livelihood, compensation shall be paid as per ADB agreed framework. Grievances mechanism.

Mr. Chiranjilal, CAPPC briefed that throughout project, public awareness activities will be carried out to develop the sense of ownership, so project can sustain for a long time through which local residents/people will get benefitted economically, socially

Smt. Madhu Nuwal, Chairman of Nagar Parishad stated that it is the responsibility of each participant to facilitate the project implementation team, so works can be executed without any hurdle. Project sustainability depends on the public, so it is also the responsibility of councilors to disseminate information to public in their respective ward to maintain the project assets once the project will be completed.

Mr. Sohan Lal, SDM requested to all the councilors to provide all required support to PIU/CMSC and Contractor for successful completion of proposed work in Bundi town

It will include: (1) the list of affected persons, with compensation, if any due to each and details of compensation paid with signed receipts annexed to the report. socio-economic status and satisfaction levels of affected persons with the Resettlement Plan implementation process, compensation and mitigation measures; (2) the list of vulnerable and additional compensation / special protection measures persons planned/implemented for them (e.g. assistance to obtain project construction related jobs); socioeconomic status and satisfaction levels of affected persons with the Resettlement Plan implementation process, compensation and mitigation measures; (3) list of roads for closure and actions planned / taken to minimize disturbance; (4) details of consultations held with affected persons (with number of participants by gender, issues raised, conclusion / agreement reached, actions required/taken; (5) details of grievances registered, redressed, outstanding complaints, minutes of GRM meetings held; (6) details of information disclosure and awareness generation activities, levels of awareness among target population and behavior change, if any; and (7) any other relevant information showing Resettlement Plan implementation progress.
